### FINDINGS OF FACTS

- 1. On May 20, 2005, the Department received an affidavit from Robert B. Hough, 177 Forest Avenue, Locust Valley, New York, stating that he is the owner of lands and the water right appurtenant as evidenced by Certificate 81304, State Record of Water Right Certificates. The affidavit further states they have obtained a different source of water for primary irrigation of these lands and requests the water right be diminished from a right for primary irrigation to a right for supplemental irrigation of the lands.
- 2. The water right to be diminished is the right described by Certificate 81304, State Record of Water Right Certificates. The water right allows the use of not to exceed 0.62 cubic foot per second (cfs), being 0.33 cfs for irrigation and 0.29 cfs for supplemental irrigation, of water from Dairy Creek, tributary to the Tualatin River, for irrigation of 26.8 acres and supplemental irrigation of 23.2 acres. The priority date is July 24, 1952. The point of diversion is located in SE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, Section 35, Township 1 North, Range 3 West, W. M..
- 3. The affidavit requests the following lands be diminished from primary irrigation to supplemental irrigation:

The quantity of water associate with the 3.7 acres equals 0.04 cubic foot per second.

#### CONCLUSIONS OF LAW

The Director of the Water Resources Department concludes that the portion of the right evidenced by Water Right Certificate 81304 as described in *Findings of Fact #3* has been diminished from primary irrigation to supplemental irrigation

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## **ORDER**

## IT IS HEREBY ORDERED:

- 1. Certificate 81304 is canceled.
- 2. The water right for irrigation of 3.7 acres as described by Certificate 81304 is diminished from a right for primary irrigation to a right for supplemental irrigation. The Department shall issue Certificate 81455, a new and superseding certificate, to confirm the diminution of the right
