ORDER APPROVING A CHANGE IN PLACE OF USE AND POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7556 submitted by

STAN AND TERESA ROLFNESS P.O. BOX 807 CHRISTMAS VALLEY, OREGON 97641

The right to be modified, as evidenced by a PORTION of Certificate 54631, was perfected under Permit G-9167 with a date of priority of DECEMBER 16, 1980. The right allows the use of 3 WELLS in the FORT ROCK BASIN for IRRIGATION of 129.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.60 cubic feet per second, being 0.68 cubic foot per second from WELL 1, 0.87 cubic foot per second from WELL 2 and 0.05 cubic foot per second from WELL 3, if available at the original well; SE¼ NW¼, SE¼ SW¼, SECTION 25, T 26 S, R 17 E, W.M.; WELL 1 - 1350 FEET SOUTH AND 1350 FEET EAST FROM THE NW CORNER, WELL 2 - 1460 FEET NORTH AND 1310 FEET EAST WEST FROM THE NW CORNER, WELL 3 - 220 FEET NORTH AND 150 FEET WEST FROM THE SOUTH ¼ CORNER, ALL SECTION 25, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

The proposed changes shall be completed on or before October 1, 1999. 1.

- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.
- 5. The former places of use shall no longer be irrigated as part of this water right.

Certificate 54631 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
