Pursuant to ORS 541.329 (District Water Rights Mapping Provision), a petition requesting approval and acceptance of district maps indicating the location and use of the water rights within and served by a district or any part thereof was submitted to the Oregon Water Resources Commission on June 29, 1993, by the petitioner:

The perfected water rights and completed transfers petitioned are evidenced by certificates 37481, 37628, 44075, 44186, 46183, 52557, 60944, 62311, and completed transfers 5478 (Special Order Volume 38, page 333), and 5727 (Special Order Volume 40, page 39). The Company has also petitioned certificate 55897 except that portion described as:

The said rights and completed transfers to be modified by the petition allow use of the waters of Little Butte Creek, a tributary of the Rogue River, for 660.87 acres of irrigation, stock and domestic use and 26.22 acres of irrigation.

^a Transfer 5727 (Special Order Volume 40, page 39) moved a portion of the rights confirmed by certificate 55897. No remaining right has been issued and a final proof survey was not conducted. The transferred portion is included in the acres listed under certificate 55897.

To summarize, the water rights involved in the petition total 687.09 acres, 595.41 acres with an 1883 priority and 91.68 acres with a 1908 priority. The seven authorized points of diversion associated with said petitioned rights are as follows:

- 1) SW¼ SE¼ Section 31, T. 35S., R. 1E., W.M. 560 feet North and 2990 feet East from the SW corner Section 31.
- 2) SW¼ SE¼ Section 36, T. 35S., R. 1W., W.M. 400 feet North and 775 feet East from S¼ corner Section 36.
- 3) Lot 1 (NW¼ NW¼) Section 2, T. 36S., R. 1W., W.M. 2245 feet North and 375 feet East from W¼ corner Section 2.
- 4) SE¼ NE¼ (Cameron DLC 45) Section 3, T. 36S., R. 1W., W.M. 1100 feet North and 780 feet West from E¼ corner Section 3.
- 5) SW¼ SE¼ Section 36, T. 35S., R. 1W., W.M. 290 feet North and 1025 feet East from S¼ corner Section 36.
- 6) NE¼ SW¼ Section 3, T. 36S., R. 1W., W.M. 1208 feet South and 645 feet West from Center ¼ corner Section 3.

A proposed order issued by the Director of the Water Resources Department on March 6, 1995, proposed to approve the petition and maps submitted by the petitioner indicating the current place of use for irrigation for the certificates listed in **Table 1**.

Pursuant to ORS 541.331 and OAR 690-13-310(4), three protests against the proposed order approving the petition were submitted. Having resolved the protests through modifications to the petition, all three individuals have withdrawn their protest. A copy of the protest withdrawals is **Attachment 1**. Specific modifications to the petition are as follows:

1) Addition of 2.0 acres of water right, certificate 55897, priority 1908, to Larry Lansburg:

SW1/4 SE1/4 Section 35, T.35S., R.1W., Taxlot 2800

2) Addition of 2.0 acres of water right, certificate 55897, priority 1908, to Grace Fitzgerald:

NE¹/₄ SE¹/₄ Section 36, T.35S., R.1W., Taxlot 801

3) Addition of 1.2 acres of water right, certificate 55897, priority 1908, to Dr. Patricia Kester:

SW¹/₄ SE¹/₄ Section 36, T.35S., R.1W., Taxlot 1303

Having modified the petition by 5.2 acres of irrigation, priority date 1908, and the modifications being made pursuant to ORS 541.331 (4), evaluated under OAR 690-13-200 and OAR 690-13-350, the petition as modified is **Attachment 2.**

The petitioner requests to change the place of use for irrigation for said certificates listed in **Table 1**, to locations described in said petition, **Attachment 2**. The petitioner also requests to combine the water right certificates involved in the petition into one certificate with two priority dates and seven points of diversion.

To summarize **Attachment 2**. (the petition), the total irrigation acreage requested for each priority date is now as follows:

Stock and domestic use shall be limited to those petitioned water rights specifically authorized for such use and shall be further limited by the restrictions and limitations described in the Little Butte Creek Decree Volume 14, page 498. As displayed below, one new certificate of water right conforming to the said petition (Attachment 2), for 657.55 acres of irrigation, stock and domestic use and 26.2 acres of irrigation should be issued.

The petitioner has requested 595.41 acres under the 1883 priority date, the same as the number of eligible acres for the 1883 priority. The petitioner has only requested 88.34 acres of the 91.68 acres eligible under the 1908 priority date, and the balance of the 1908 water rights, 3.34 acres, is requested by petition and specific request to be cancelled. The water rights to be cancelled are associated with certificate 55897.

FINDINGS

The Water Resources Director has examined the petition and maps submitted by Little Butte Irrigation Company and a report prepared by Department staff. Said report is on file at the Water Resources Department. Based upon the examination and report, the Director finds:

- 1. Little Butte Irrigation Company is a "district" as defined in ORS 541.325(1).
- 2. The Company filed its petition and maps in a timely manner.
- 3. The Company paid the fees required under ORS 536.050 1(o).
- 4. The Company certified that the notice requirements of ORS 541.329 (4) were met.
- 5. The Company has met the notice requirements of ORS 541.329(5).
- 6. The content and quality of the Company's petition and maps meet the requirements of ORS 541.329.
- 7. The acreage petitioned is within the limits of the eligible water rights and the limits set in ORS 541.331(4).
- 8. Three protests pursuant to ORS 541.331(1) were filed and, after modifications to the petition, were withdrawn.
- 9. Modifications to the petition following the issuance of a proposed order issued March 6, 1995, were made pursuant to ORS 541.331(4) and evaluated under OAR 690-13-200 and OAR 690-13-350(1).
- 10. The proposed changes may be made without injury to existing water rights.
- 11. Before the Department issues confirming certificate, overlapping water rights shall be resolved.

Therefore the Director finds that LITTLE BUTTE IRRIGATION COMPANY has met the requirements of ORS 541.325 to 541.333.

FINAL ORDER

NOW THEREFORE, it is hereby ORDERED that the petition for Little Butte Irrigation Company's maps of water rights is accepted and approved and certificates 37481, 37628, 44075, 44186, 46183, 52557, 55897, 60944, and 62311 are cancelled.

It is FURTHER ORDERED that transfer 5478 (Special Order Volume 38, page 333), and transfer 5727 (Special Order Volume 40, page 39) are confirmed.

It is FURTHER ORDERED that one new certificate of water right conforming to the said petition (Attachment 2), be issued for two priority dates, seven points of diversion and the uses as displayed below.
