ORDER APPROVING TEMPORARY CHANGES IN PLACE OF USE
AND POINT OF DIVERSION

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 7961 submitted by

BUREAU OF LAND MANAGEMENT

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for WHEELER County as evidenced by a PORTION of Certificate 13575. The decree is recorded in the Order Record of the Water Resources Director in Volume 12, at Page 388. The date of priority is 1882.

The right allows the use of BRIDGE CREEK, a tributary of the JOHN DAY RIVER, for IRRIGATION of 1.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH OF ONE CUBIC FOOT PER SECOND (0.030 cfs) PER ACRE OF LAND BEFORE JUNE 15, AND ONE EIGHTIETH OF ONE CUBIC FOOT PER SECOND (0.015 cfs) PER ACRE AFTER JUNE 15, DURING THE IRRIGATION SEASON FROM MARCH 1 TO OCTOBER 1 OF EACH YEAR, if available at the authorized point of diversion: MANNING DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

SE $\frac{1}{4}$ SE $\frac{1}{4}$ 0.4 ACRE
SECTION 14

SE $\frac{1}{4}$ NE $\frac{1}{4}$ 0.8 ACRE
SECTION 23

TOWNSHIP 10 SOUTH, RANGE 20 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to TEMPORARILY change the place of use to:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ 1.2 ACRES
SECTION 11
TOWNSHIP 10 SOUTH, RANGE 20 EAST, W.M.

The applicant proposes to TEMPORARILY change the point of diversion to:

SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 11, T 10 S, R 20 E, WM; 4513 FEET SOUTH AND 1836 FEET EAST FROM THE NW CORNER, SECTION 11.

The applicant proposes the temporary changes be for the 1998 through the 2000 irrigation seasons.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The change is temporary. The change shall be effective upon issuance of this order.
2. The former places of use shall not be irrigated as part of this water right during the 1998, 1999, and 2000 irrigation seasons.
3. The use shall revert to the authorized place of use at the end of the 2000 irrigation season.
4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
5. The use of the remaining water right described by Certificate 13575 shall continue to be in accordance with the terms and conditions of Certificate 13575.
