confirms the right of record to use the waters of UMATILLA RIVER, tributary to COLUMBIA RIVER, for IRRIGATION OF 27.8 ACRES.

This right was perfected under Permit S-25924. The date of priority is JUNE 27, 1958. The amount of water to which this portion of the right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.2 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in Certificate 76051.


NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This order is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 28, 2007, at Special Order Volume 71, Page 271, approving Transfer Application 8418, affecting a portion of Certificate 76051, State record of Water Right Certificates.

The Department will issue a superseding certificate describing the right when it determines that it is necessary for record keeping.
