On March 22, 2004, the Deschutes Water Exchange Mitigation Bank submitted an instream lease application for the purpose of protecting flows instream and generating mitigation credits to offset the impacts of ground water use in the Deschutes Ground Water Study Area.

#### FINDINGS OF FACT

### Short-Term Instream Lease

1. A Short-Term Lease Application, which proposed to lease a portion of certificate 74135 for instream purposes was submitted to the Department by:

- 2. The Department assigned this lease agreement number L-500.
- 3. The lease application includes the required information under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
- 4. The right to be leased, as requested by the applicant, is as follows:

**Priority Date:** 1887, 1895, 1899 & 1904

Use:

Irrigation

Acres:

267.7 acres, being 12.5 acres under the 1887 priority date, 248.5 acres under

the 1895 priority date, 5.2 acres under the 1899 priority date, and 1.5 acres

under the 1904 priority date.

Season of Use: This water right does not have an irrigation season established by certificate

or by decree. The Department uses as an irrigation season pursuant to OAR

690-250-0070(1) March 1 through October 31.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

Quantity: 5.35 Cubic Foot per Second (CFS). This water right does not have a duty

limitation.

5. The Department finds that the lease application requires modification in order to clarify the amount of water being leased under each priority date. The right is clarified as follows (changes are shown in bold text):

Certificate: 74135

Priority Date: 1887, 1895, 1899 & 1904

Use: Irrigation

Acres: 267.7 acres, being 12.5 acres under the 1887 priority date, 248.5 acres under

the 1895 priority date, 5.2 acres under the 1899 priority date, and 1.5 acres

under the 1904 priority date.

Season of Use: This water right does not have an irrigation season established by certificate

or by decree. The Department uses March 1 through October 31 as an

irrigation season pursuant to OAR 690-250-0070(1).

Quantity: 5.35 Cubic Foot per Second (CFS), being 0.25 CFS under the 1887

priority date, 4.97 CFS under the 1895 priority date, 0.1 CFS under the 1899 priority date, and 0.03 CFS under the 1904 priority date. This

water right does not have a duty limitation.

Source: Squaw Creek, tributary to the Deschutes River

6. The application proposes to lease water for instream as follows:

Reach: From the POD (SW SW, Section 21, T15S, R10E, W.M., 998 Feet North and 1211 Feet East from the SW Corner, Section 21) to the mouth of Squaw Creek and thence to Lake Billy Chinook.

- 7. The Department finds that water may only be protected at the rate and volume requested for a period of 74 days. On May 13, 2004, the Deschutes Water Exchange Mitigation Bank (the Lessor) submitted a request to amend the application to reduce the rate such that water may be protected over the full period requested in the application.
- 8. The Department finds that clarification of the amount of water to be leased under each priority date is necessary.
- 9. Therefore, the Department finds that water may be leased instream as follows (changes are shown in bold text):

Reach: From the POD (SW SW, Section 21, T15S, R10E, W.M., 998 Feet North and 1211 Feet East from the SW Corner, Section 21) to the mouth of Squaw Creek and thence to Lake Billy Chinook.

10. Based upon continued review of the application, the Department finds that the following condition is necessary:

The portion of water protected under this lease shall be based on the same percentage diversion and delivery rate that Squaw Creek Irrigation District is diverting to rights of

the same priority within the district. Each Monday morning during the period of this lease, the District shall report to the District 11 Watermaster's office the percentage diverted under the 1887, 1895, 1899 & 1904 priority dates. This information only needs to be reported to the Watermaster's office once the District is diverting water on a percentage basis. Subsequent reports only need to be made to the Watermaster's office when changes are made to the percentage of water being diverted. Once the District begins diverting water on a percentage basis, the amount water leased instream will be adjusted by that same percentage.

- 11. Based upon review of the application and information provided by the Department's Watermaster, the Department finds that the lease, as proposed and modified above, will not result in injury or enlargement.
- 12. The lease will terminate on October 31, 2004.

## Preliminary Award of Deschutes Basin Mitigation Credits

- 13. The Lessee, the Deschutes Water Exchange, a mitigation bank chartered by the Water Resources Commission, has requested that this instream lease application be used to establish mitigation credits in the Deschutes Ground Water Study Area. Any mitigation credits generated from this project are to be assigned to the Deschutes Water Exchange Mitigation Bank.
- 14. The Department assigned this mitigation credit project number MP-17.
- 15. The Department provided notice of the mitigation credit project pursuant to OAR 690-521-0300 (6). The Department also provided notice of the mitigation credit project to the Oregon Department of Fish and Wildlife, Oregon Department of Environmental Quality, Oregon State Parks and Recreation Department, Oregon Division of State Lands, the Oregon Department of Agriculture, and the Department's Watermaster pursuant to OAR 690-521-0300 (7) and OAR 690-505-0630 (2). Comments were received from the Watermaster and the Oregon Department of Fish and Wildlife (ODFW). ODFW made general comments on the mitigation program. Neither the Watermaster nor ODFW made any specific recommendations on how to enhance resource benefits and make the most effective use of the mitigation project and the mitigation water (credits) generated by the project.
- 16. No modifications were made to the lease based upon comments received.
- 17. When the Department originally published notice of this mitigation project, it was identified that the project may generate 481.9 mitigation credits. However, based upon additional evaluation, the Department has determined that water used for irrigation under the 1899 and 1904 priority dates is not available at least half of the irrigation season and may not be used to establish mitigation credits. The determination of the amount of mitigation credits generated is therefore based upon the 261.0 irrigated acres to be leased with the 1887 and 1895 priority dates, which are available at least half of the irrigation season. The Department finds that 469.8 mitigation credits may be awarded to this mitigation credit project and assigned to the Deschutes Water Exchange Mitigation Bank.
- 18. The mitigation credits may be used to mitigate for ground water permit applications and existing conditioned ground water permits and certificates, providing mitigation pursuant to

the Deschutes Ground Water Mitigation Rules, OAR Chapter 690, Division 505, within the **Squaw Creek and General** zone(s) of impact.

- 19. The mitigation credits expire on December 31, 2004.
- 20. The use and maintenance of the mitigation credits is subject to the terms and conditions of the Deschutes Water Exchange Mitigation Bank Charter.
- 21. The Department shall award final mitigation credits upon completion of the approved project by the applicant and verification by the Department that the project is complete. The issuance of the Final Order for the proposed instream lease shall result in completion of the project and verification that the project is complete.
- 22. No precedent is set by this Final Order as to the amount of mitigation credits that may be generated by a subsequent mitigation credit project.

#### CONCLUSIONS OF LAW

The Department concludes that the lease, as modified above, will not result in injury or enlargement, OAR 690-077-0077.

This mitigation project results in mitigation credits pursuant to ORS 537.746 and OAR 690-521-0300 and 690-521-0400.

#### ORDER

Therefore, it is ORDERED:

- 1. That the Short-Term Lease described herein is APPROVED.
- 2. The authorized place of use shall not be irrigated during the term of this lease.
- 3. Water is leased instream as follows:

Reach: From the POD (SW SW, Section 21, T15S, R10E, W.M., 998 Feet North and 1211 Feet East from the SW Corner, Section 21) to the mouth of Squaw Creek and thence to Lake Billy Chinook.

4. The portion of water protected under this lease shall be based on the same percentage diversion and delivery rate that Squaw Creek Irrigation District is diverting to rights of the same priority within the district. Each Monday morning during the period of this lease, the District shall report to the District 11 Watermaster's office the percentage diverted under the 1887, 1895, 1899 & 1904 priority dates. This information only needs to be reported to the

Watermaster's office once the District is diverting water on a percentage basis. Subsequent reports only need to be made to the Watermaster's office when changes are made to the percentage of water being diverted. Once the District begins diverting water on a percentage basis, the amount water leased instream will be adjusted by that same percentage.

- 5. The lease will terminate on October 31, 2004.
- 6. Final Award of Deschutes Basin Mitigation Credits: Issuance of this Final Order results in completion of the project and verification by the Department that the project is complete. The Department concludes that the mitigation credit project is awarded mitigation credits, as described above, pursuant to OAR 690-521-0400 and ORS 537.746. Mitigation Credits, in the amount of 469.8 credits, as described herein, are awarded to this mitigation project and assigned to the Deschutes Water Exchange Mitigation Bank. Mitigation Credits may be used to satisfy a mitigation obligation of a ground water permit applicant and/or ground water permit/certificate holder in the Squaw Creek and General zone(s) of impact.
- 7. Mitigation credits are valid until used (or expire) to satisfy a mitigation obligation of a ground water permit applicant and/or ground water permit/certificate holder within the Deschutes Ground Water Study Area pursuant to the Deschutes Ground Water Mitigation Rules. Mitigation credits are used when a person submits to the Department documentary evidence that valid credits have been obtained and assigned to satisfy a mitigation obligation.
- 8. The mitigation credits shall expire on December 31, 2004.
- 9. The use and maintenance of the mitigation credits shall be subject to the terms and conditions of the Deschutes Water Exchange Mitigation Bank Charter.
