IN THE MATTER OF THE APPLICATION OF GEO. L. JANTZER LUMBER COMPANY FOR THE APPROVAL OF A CHANGE IN CHARACTER OF USE OF WATER FROM MILL CREEK, PURSUANT TO THE PROVISIONS OF SECTION 116-606, O.C.L.A.

ORDER

APPROVING APPLICATION

On August 9, 1944, the Geo. L. Jantzer Lumber Company of Prospect, Oregon, filed an application for a change in character of use of water from Mill Creek, a tributary of North Fork Rogue River.

Certificate of water right recorded at Page 14341, Volume 12, State Record of Water Right Certificates, was issued to the Geo. L. Jantzer Lunter Company, for the use of 0.60 cubic foot per second of the water of Mill Creek for steam boiler purposes and 0.40 cubic footper second for mill pond purposes in the SE NW4, Section 10, Township 33 South, Range 2 East, W. M., with a date of priority of March 19, 1941.

The applicant herein, owner of the above described land and water right, proposes to change the use of O.ll cubic foot per second from Mill pond use to that of domestic purposes for eleven families.

Notice by publication as provided by Section 116-606, 0. C. L. A., was given to the Medford Mail Tribune, a newspaper of general circulation in Jackson County, for a period of at least 3 weeks and not less than 1 publication each week, said notice being published in the issues of September 1, 8, and 15, 1944.

It appears that no objections were filed against the approval of the proposed transfer. It further appears that the proposed change in character of use of water may be made without injury to existing rights and that the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in character of use of water be and the same hereby is approved and that the right to the use of O.ll cubic foot per second of the water of Mill Creek for mill pond use in the SEA NWA, Section 10, Township 33 South, Range 2 East, W. M., with a date of priority of March 19, 1941, be severed therefrom and simultaneously and without loss of priority changed to domestic use within said SEA NWA, Section 10, Township 33 South, Range 2 East, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use for domestic purposes shall be made on or before October 1, 1945 or such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that upon receipt of proof, satisfactory to the State Engineer, of complete application of water to beneficial use for domestic purposes, a certificate of water right shall be issued to the Geo. L. Jantzer Lumber Company and certificate of water right recorded at Page 14341, Volume 12, State Record of Water Right Certificates be cancelled.
