confirms the right of record to use the waters of MCKAY RESERVOIR, constructed under Permit R-564, tributary to MCKAY CREEK, for SUPPLEMENTAL IRRIGATION OF 46.2 ACRES.

This right was perfected under Permit S-7400. The date of priority is JULY 1, 1924.

Water is run down the natural channels of McKay Creek and the Umatilla River and is re-diverted at Westland Irrigation District Canal.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This order is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 28, 2007, at Special Order Volume 71, Page 271, approving Transfer Application 8418, affecting a portion of Certificate 79439, State record of Water Right Certificates.

The Department will issue a superseding certificate describing the right when it determines that it is necessary for record keeping.
