ORS 537.211 establishes the process in which a water right permit holder may submit a request to change the point of appropriation and/or place of use authorized under an existing water right permit.

## **Applicant**

Red Hills Farm, LLC, 15909 NE McDougall Road, Dayton, Oregon 97114.

### **Findings of Fact**

- Red Hills Farm, LLC, filed an application to add an additional point of appropriation to Well 6 under Permit G-13083. The Department assigned the application number T-9455.
- The permit to be amended is as follows:

Permit:

G-13083, in the name of William H. Stoller;

Use:

Irrigation and industrial use (winery);

Priority Date: November 4, 1994;

Quantity:

A cumulative total not to exceed 0.579 cubic foot per second (cfs) at any one time, being 0.579 cfs from Wells 2, 3, 4, 5, 6, and 7 for irrigation and 0.071 cfs from Well 4 for industrial use (winery), and further limited to 0.156 cfs from Well 7, 0.029 cfs from Well 2, 0.111 cfs from Well 3, 0.071 cfs from

Well 4, 0.123 cfs from Well 5, and 0.089 cfs from Well 6;

Rate/Duty:

The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to ONE-

EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

Wells 2, 3, 4, 5, 6, and 7, in the Yamhill River Basin.

- 4. Notice of the application for permit amendment was published pursuant to ORS 540.520(5). No comments were filed in response to the notice.
- 5. The permit holder, William H. Stoller, has given written permission for the permit amendment to take place.
- 6. The change would not result in injury to other water rights.
- 7. The change does not enlarge the permit.
- 8. The change does not alter all other terms of the permit.

#### Conclusion of Law

The additional point of appropriation for Well 6 proposed by Permit Amendment Application T-8455 is consistent with the requirements of ORS 537.211.

## Now, therefore, it is ORDERED:

The change and subsequent use of water shall be subject to the following conditions:

- 1. The combined quantity of water diverted at the new point of appropriation (Well 6A), together with that diverted at the old point of appropriation (Well 6), shall not exceed the maximum rate and duty allowed for Well 6 under Permit G-13083.
- 2. A. Prior to water use from the proposed point of appropriation, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, and shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.

- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- 3. Water shall be acquired from a single basalt aquifer within the same basalt aquifer as the original point of appropriation (Well 6).
- 4. All other terms and conditions of Permit G-13083 remain the same.
- 5. Permit G-13083, in the name of William H. Stoller, is amended as described herein.
