ORDER
APPROVING APPLICATION

On August 31, 1936, the County Court of Deschutes County filed an application for the approval of a change in place of use of water within the boundaries of the Squaw Creek Irrigation District, pursuant to Section 1, Chapter 267, Oregon Laws 1931.

Deschutes County has acquired title to the lands hereinafter described as Tract No. 1, and, upon request of the Squaw Creek Irrigation District, proposes to transfer the water rights appurtenant thereto to the lands hereinafter described as Tract No. 2.
