On August 19, 1987, an application was filed in the office of the Water Resources Director by William B. Coit, dba Loma Vista Farms for approval of changes in place of use and point of appropriation of water from ground water, pursuant to the provisions of ORS 537.705.

The right established by performance under the terms of prior Transfer 5815 in the name of Jeremiah O'Leary, describes a right for the use of not to exceed 1.77 cubic foot per second from a well located 1370 feet South and 1430 feet East from the Northwest corner of Section 6, being within the SE 1/4 NW 1/4 of Section 6, Township 27 South, Range 16 East, WM for irrigation of:

with a date of priority of January 26, 1981.

The applicant herein, owner of the lands above described, proposes to change the place of use therefrom to irrigation of:

36.0 acres NE 1/4 NW 1/4
35.0 acres NW 1/4 NW 1/4
35.9 acres SW 1/4 NW 1/4
35.0 acres SE 1/4 NW 1/4
Section 2
Township 25 South, Range 18 East, WM

and to change the point of appropriation to a well located 1320 feet South and 1320 feet East from the Northwest Corner of Section 2, being within the SE 1/4 NW 1/4 of Section 2, Township 25 South, Range 18 East, WM.

Notice of the application, pursuant to ORS 540.520(2), was published in the Lake County Examiner, a newspaper having general circulation in the area in which the water right is located, for a period of three weeks in the issues of September 24, October 1 and 8, 1987.

Dennis R. Glender, Watermaster, has filed a statement to the effect that the proposed changes in place of use and point of appropriation may be made without injury to existing rights.

Donn Miller, Hydrogeologist, has filed a statement to the effect that the proposed changes in place of use and point of appropriation may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in place of use and point of appropriation may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed changes in place of use and point of appropriation are approved, without loss of priority.

Approval of a water right transfer application does not confirm the status of the right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

It is FURTHER ORDERED that the quantity of water appropriated at the new well shall not exceed the quantity of water available at the old well under the subject right, and shall not exceed 1.77 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install measuring devices:

That the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

It is FURTHER ORDERED that the subject water right is hereby severed from the place of use described in Transfer 5815, and shall be beneficially used as authorized by this order on or before October 1, 1989.

It is FURTHER ORDERED that the right to appropriate water from the Well described in Transfer 5815 is hereby canceled, and water shall be appropriated from the new well on or before October 1, 1989.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the Jeremiah O'Leary.
