Authority

Findings of Fact

Background

- On June 11, 2008, TUCKER MAYBERRY filed an application to change the place of use under Certificate 80795. The Department assigned the application number T-10653.
- On March 7, 2008, Certificate 80795 was superseded by Certificate 83850. 2.
- 3. On April 8, 2009, the Department recorded an assignment of Transfer Application T-10653 to River Steppes Prineville, LLC, an Oregon Limited Liability Company.
- The portion of the right to be transferred is as follows:

IRRIGATION of 2.0 ACRES Use:

under any other right existing for the same lands, is limited to a diversion

- 6. Notice of the application for transfer was published on June 24, 2008, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 7. On June 1, 2009, the Department mailed a copy of the *draft* Preliminary Determination proposing to approve Transfer Application T-10653 to the applicant. The cover letter that accompanied the draft Preliminary Determination set forth a deadline of July 2, 2009, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 8. On July 21, 2009, the Department issued a Preliminary Determination proposing to approve Transfer Application T-10653 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on July 28, 2009, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 9. Temporary Transfer T-10842 affects the same place of use as the proposal contained in Transfer Application T-10653. At the applicants request, Temporary Transfer Application T10842 (recorded in Special Order Volume 77, Pages 947 – 949) will be terminated upon issuance of the final order for Transfer Application T-10653.

Transfer Review Criteria

- 10. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the file that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- 11. A pump sufficient to use the full amount of water allowed under the existing right is present.
- 12. The proposed change would not result in enlargement of the right.
- 13. The proposed change would not result in injury to other water rights.

Conclusions of Law

The change in place of use proposed in Transfer Application T-10653 is consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. Temporary Transfer, recorded in Special Order Volume 77, Pages 947-949, is terminated and is of no further force or effect.
- 2. The change in place of use as proposed in Transfer Application T-10653 is approved.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 83850 and any related decree.
- 4. Water right certificate 83850 is modified. The Department will issue a superseding certificate describing the right when it determines that is necessary for record keeping.
- 5. The former place of use of the transferred right shall no longer receive water under the right.
- 6. The approved change shall be completed and full beneficial use of the water shall be made on or before **October 1, 2011**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change(s) and full beneficial use of the water.
