ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8509 submitted by

ZELMA K. WEATHERMON
78778 S. FORK WALLA WALLA RIVER ROAD
MILTON-FREEWATER, OREGON 97862.

The right to be modified, was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County as evidenced by a PORTION of Certificate 12894. The decree is recorded in the Order Record of the Water Resources Director in Volume 12, at Page 9. The date of priority is 1888.

The right allows the use of SOUTH FORK WALLA WALLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 0.67 ACRE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed one and one-half miner's inches per acre, if available at the authorized point of diversion: ROBERTS DITCH - NE¼ SW¼, SECTION 10, T 4 N, R 37 E, W.M..

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$ 0.67 ACRE (TAXLOT 2001)
SECTION 10
TOWNSHIP 4 NORTH, RANGE 37 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the point of diversion to:

NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 10, T 4 N, R 37 E, W.M.; 670 FEET SOUTH AND 1535 FEET EAST FROM THE W $\frac{1}{4}$ CORNER, SECTION 10.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2005.
2. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


- 4. Water shall be acquired from the same surface water source as the original point of diversion.
- 5. The water user shall install and maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction and shall be installed under the supervision of the Department of Fish and Wildlife.

The water user may participate in the Oregon Department of Fish and Wildlife's cost sharing program for installation of screening and by-pass devices in accordance with ORS 540.525.

Certificate 12894 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer and transfers T-8474 and T-8479. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
