The right to be modified, as evidenced by Certificate 42427, was perfected under Permit G-3238 with a date of priority of JULY 19, 1966. The right allows the use of BOEING WELL #2, in the WILLOW CREEK BASIN, for INDUSTRIAL USE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.10 cubic foot per second, if available at the original well; SE% NW%, SECTION 25, T 3 N, R 23 E, W.M.; 2610 FEET SOUTH AND 1510 FEET EAST FROM THE NW CORNER, SECTION 25, or its equivalent in case of rotation, measured at the well.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

This is an order other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

- 2. The water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water appropriated for exempt uses and permitted uses. The water user must be able to separate and account for exempt uses and permitted uses respectively. The type and plans of the measuring device must be approved by the Watermaster prior to beginning construction and shall be installed under the general supervision of the Department.
- 3. The former place of use shall no longer receive water for industrial use as part of this water right.

Certificate 42427 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
