ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Applicant

Butter Creek Irrigation District P.O. Box 110 Hermiston, OR 97838

Findings of Fact

- 1. On April 13, 2006, Butter Creek Irrigation District filed a district transfer application to temporarily change the place of use, and the type of use from irrigation to supplemental irrigation. The Department assigned the application number T-10128.
- 2. Notice of the application for transfer was published pursuant to ORS 540.580 and OAR 690-385-3400. No comments were filed in response to the notice.
- 3. Pursuant to OAR 690-385-3130 the applicant applied to temporarily change the type of use of the water rights proposed for transfer under Certificates 80705, 81408, 81409, and 63802 from irrigation to supplemental irrigation. Permit 51017 is the authorized irrigation water right at the proposed place of use.
- 4. The portion of the first water right to be transferred is as follows:

- 18. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 19. The proposed changes in place of use would not result in enlargement of the rights.
- 20. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The proposed changes in application T-10128 satisfy the requirements of ORS 540.574(3) and 540.570.

Now, therefore, it is ORDERED:

1. The proposed changes to the water rights evidenced by Certificates 80705, 81408, 81409 and 63802 are approved.

- 2. The temporary transfer is effective for the 2006 irrigation season.
- 3. The right to the use of the water is restricted to beneficial use at the new temporary place of use described and is subject to all other conditions and limitations contained in Certificates 80705, 81408, 81409 and 63802 and any related decree.
- 4. Pursuant to OAR 690-385-3130, the use of water under Certificates 80705, 81408, 81409 and 63802 for supplemental irrigation at the new temporary place of use shall not exceed the maximum rate and duty prescribed by Permit 51017. The use of water under Certificates 80705, 81408, 81409 and 63802 at the new temporary place of use may be used only to make up a deficiency in supply for Permit 51017.
- 5. The applicant shall not use water under Permit 46499 during the 2006 irrigation season at the authorized place of use.
- 6. The use of water on the lands from which the water right is transferred and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
- 7. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- 8. At the end of the 2006 irrigation season all uses of water under this temporary transfer revert automatically to the terms and conditions of the original water right permit, certificate, or adjudication as evidenced by a court decree.
