On November 9, 1981, an application was filed in the office of the Water Resources Director by Stafford Hansell for approval of changes in place of use and point of appropriation of water from ground water, pursuant to the provisions of ORS 537.705.

The affected right is described by Water Right Permit G-3822, in the name of Hansell Brothers, Inc., and is for the use of not to exceed 5.0 cubic feet per second from Wells 3, 4 and 5, under a priority date of February 15, 1968, for primary irrigation from Well 3, with any deficiency made up from Wells 4 and 5, of:

Notice of the application, pursuant to ORS 540.520(2), was published in the East Oregonian, a newspaper printed and having general circulation in Umatilla County, Oregon, for a period of three weeks in the issues of November 23, 30 and December 7, 1981.

Steven P. Applegate, Watermaster, has filed a statement to the effect that the proposed changes in place of use and point of appropriation may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in place of use and point of appropriation may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested changes in place of use and point of appropriation, as described herein, without loss of priority, are approved.

It is FURTHER ORDERED that the quantity of water appropriated at the new well shall not exceed the quantity of water available at the old wells under the subject right.

It is FURTHER ORDERED that the following provisions shall be carried out prior to using water from the new well as herein confirmed:

That the pump system shall include an in line flow meter or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that NO time need be fixed for completion as the changes in place of use and point of appropriation are completed.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
