**Disposition**

The Water Resources Department (Department) adopts, as supplemented and modified herein, the Hearing Officer’s Ruling on Legal Issues resolving the legal issues in this matter and dismissing the contested case for lack of any relevant factual issues. Consistent with the Hearing Officer’s Proposed Order, the Department approves Petitioner West Extension Irrigation District’s (WEID or District) water rights mapping petition, as amended to show the irrigation of 21.40 acres (located in T4N, R24E, Section 24, Tax Lot 500) by Pat and Leslie Suter.

**Appeal Rights**

You are entitled to judicial review of this order. Judicial review may be obtained by filing a petition for review within 60 days from the date of service of this Order. If this Order was personally delivered to you, the date of service is the day you received the Order. If this Order was mailed to you, the date of service is the day it was *mailed*. Judicial review, pursuant to the provisions of ORS 536.075, is to the Oregon Court of Appeals. If you do not file a petition for judicial review within the 60-day time period, you will lose your right to appeal.

## History

All of the above named Protestants submitted timely protests to the Department's proposed order approving WEID's water rights mapping petition under ORS 541.329, also known as a 3111 petition. Upon receipt of the protests, the Department referred the matter to the Office of Administrative Hearings to conduct a contested case hearing, pursuant to ORS 541.331. Petitioner WEID was represented by attorney David Van't Hof. The Department was represented by Sharyl Kammerzell, Department of Justice and Adam Sussman, Water Resources Department. Protestants were self-represented except for Protestant Suter who was represented by attorney Christopher L. Cauble. Hearing Officer Paul Vincent held a Prehearing Conference on the above-entitled matter on June 26, 2001. By order dated July 3, 2001, the Hearing Officer found that the issues to be resolved at hearing were to be determined through written briefing. Protestants were required to file a statement of issues identifying the issues before the Hearing Officer, stating why the issues were before the Hearing Officer, and stating why any alleged injuries are legally cognizable under this review process. Protestants James P. and Leslie Suter and Mary Reade filed issue statements in the matter. Petitioner and the Department filed separate responses, moving for a ruling on legal issues and requesting dismissal of the contested case for lack of any evidentiary matters. Protestants Suter filed a reply.

On November 29, 2001, the Hearing Officer issued an order ruling in Petitioner's favor on the legal issues, dismissing the contested case in the absence of any need for an evidentiary hearing, and proposing approval of Petitioner's 3111 petition. Protestants Suter submitted timely exceptions to the Hearing Officer's Ruling on Legal Issues and Proposed Order.

On October 20, 2004, the Department Served the Hearing *Officer's Ruling on Legal Issues and Proposed Order* on parties not originally served. Those parties were provided until November 18, 2004, to file exceptions. Those parties filed no exceptions.

## **Discussion of Contested Case Legal Issues**

Having considered the arguments and accompanying documents submitted by the parties, including the exceptions to the Hearing Officer's Proposed Order submitted by Protestants Suter, which are addressed below, I concur with the Hearing Officer's rulings.

### Standard of Review

Pursuant to OAR 137-003-0580, Motion for Ruling on Legal Issues, a motion for ruling on a legal issue shall be granted if 1) the pleadings, affidavits and supporting documents and the record in the contested case show that there is no genuine issue as to any material fact that is relevant to resolution of the legal issue as to which a decision is sought, and 2) the agency or party filing the motion is entitled to a favorable ruling as a matter of law.

### Remaining Protestants

On July 3, 2001, Hearing Officer Vincent issued an order requiring Protestants desiring to participate in the hearing to file a Statement of Issues in this matter by July 20, 2001. The only parties to have done so were James P. and Leslie Suter and Mary Reade. All other Protestants chose not to do so after notice and are therefore dismissed from this contested case.

### Protestants Can Raise Issues Not Raised in their Protests

Petitioner WEID requested that the issues for hearing be limited to those explicitly raised in Protestants' protests filed in November 2000. (WEID Response at 2). ORS 541.329 and OAR Chapter 690, Division 13 do not require a timely filed protest to raise all issues and arguments. *Compare* ORS 537.170(5) (requiring a protest to a water right application to raise all reasonably ascertainable issues). To the extent additional issues raised by Protestants in their Statement of Issues for hearing are reasonably related to a determination of injury resulting from the changes proposed in the District's petition, such issues may be raised in the contested case.

Whether WEID's 3111 Petition Will Cause Injury To Existing Water Rights Through Alteration of Priority Dates

Protestants argue that the petition will cause injury to existing water rights by altering the “assignments of water right regarding priority dates within the district.” (Suter Statement of Issues at 5; *see also* Reade at pp1). In support, Protestants cite to OAR 690-0210-0070, which is not applicable to petitions under ORS 541.329, although it does provide a description of injury. However, “injury” is specifically defined at OAR 690-380-0100(3), and formerly defined at OAR 690-15-005(5), as a question of whether a proposed petition would “result in a water right not getting the water to which it is legally entitled.” The Department and Petitioner argue that, as a matter of law, there is no such injury. (Department’s Response at 4; Petitioner’s Response at 3).

Protestants argue that because priority dates “up-ditch” are proposed for change, their water rights will be injured. However, such changes, as a legal matter, cannot constitute injury here because the amount of water Protestants are lawfully entitled to under their water rights is an amount of water at a *point of diversion* from the natural source of supply, in this instance the Umatilla River and the Columbia River. (Department’s Response at 4-5). The amount of water at Protestant’s “takeout point” is a matter of water management to be resolved contractually between the Protestants and Petitioner. With respect to irrigation districts, the Department’s regulatory authority ends at the diversion point from the source. ORS 540.045. The delivery of water within the District is a contractual matter between the District and its patrons, and is outside the Department’s jurisdiction. ORS 540.270. This issue is more properly seen as an opinion by the Protestants that the change of priority dates is likely to hamper the District’s ability to manage water delivery, rather than an assertion that the petition will “result in a water

right not getting the water to which it is legally entitled” at the diversion point. (Department’s Response at 4-5).<sup>1</sup>

*Whether The Petition Illegally Includes Water Rights From Inundated Lands And Other Unused Water Rights*

Protestants agree that the responses and attachments filed by Respondents resolve the issues related to the question as to whether “inundated” lands or other unused water rights are included in the 3111 Petition. (Suter Reply at 1).

*Whether the Petition Inappropriately Includes Land Only Officially Included in 1994 and Therefore Improperly Expands The Irrigation District*

ORS 541.329 provides that a petition shall contain no more acres of land than the lesser of the following: (a) the number of acres assessed by the district as of July 1, 1989 or (b) the number of acres assessed by the district as of July 1, 1993. ORS 541.329(3)(a) and (b).

Protestants assert that the petition violates ORS 541.329(3) because the District Board of Directors did not issue a “formal order” including certain lands until July 28, 1994. Protestants argue that to the extent that the lands included in 1994 are included in the 3111 petition, the lack of a formal order results in an unlawful attempt to expand the District. (Suter at 6-7).

The Hearing Officer concluded, and I agree that Protestant Suter has not alleged facts that show a violation of ORS 541.329(3). The Department has supplied uncontradicted evidence that the number of acres assessed by the District as of July 1, 1989 was 9752.0 acres and that the number of acres assessed by the District as of July 1, 1993 was 9901.41 acres. The 3111 petition includes only 9254.80 acres, less than either of these assessments.

<sup>1</sup> The Hearing Officer agreed with the Department that Petitioner’s arguments regarding water right ownership are not relevant to the determination of whether there is injury pursuant to ORS 541.329 and did not address the argument further.

Additionally, I concur with the Hearing Officer's conclusion that the petition does not create an illegal expansion of a water right under ORS 541.331(4). Protestant's argument regarding the lack of a written final order including certain lands until 1994 seems to be directed to the requirement in ORS 541.331(4) that the "to" lands within the petition be within the petitioner's district. As Petitioner WEID argues, Petitioner's request to add lands, which was initiated prior to July 1, 1993, meets the requirements of ORS 541.331(4)(b).<sup>2</sup>

*Whether Discrepancies Related To The Amount Of Acres Actually Assessed And Acres Petitioned Must Be Resolved Prior To Approval*

Protestants' allege that discrepancies related to the amount of acres actually being assessed to Protestants and the amount they are receiving under the 3111 petition must be resolved at hearing. For purposes of resolution prior to hearing, the District did not oppose a finding that the proposed 3111 petition be modified to award the Suters the 21.4 acres they seek. Accordingly, this issue is resolved without need for further hearing.

*Whether WEID Failed To Provide Sufficient Notice And Full Disclosure*

Protestants claim that Petitioner failed to provide sufficient notice and failed to fully disclose to Protestants that there is a rebuttable presumption under ORS 541.329(4) that the amount of irrigated acres of a landowner should be the same as the amount of acres assessed in the previous five years. Protestant's have no evidence (for instance, through affidavit) that would lead a fact finder to conclude that Petitioner's required notices were insufficient. Moreover, even if there was a procedural error in Petitioner's notice, Protestants have not been

<sup>2</sup> Protestant Suter's Exhibit C makes clear that Petitioner's board, after notice and hearing, gave formal approval to all requested inclusions at a March 4, 1993 board meeting. The fact that WEID did not issue a formal order of inclusion until after July 1, 1993 is irrelevant to the issue of whether the land was assessed on July 1, 1993.

harmd insofar as they have taken this petition to a contested case and been afforded all of the process to which they are due.

District Right Of Way

Protestant Reade's hearing papers (filed in the form of a letter to be forwarded to the Hearing Officer), raise several concerns regarding the location and survey of the District's right of way. I agree with the Hearing Officer's conclusion that these matters are beyond the jurisdiction of the Department and not relevant to the determination of injury to an existing water right as that term is used in ORS 541.329.

**Response to Exceptions**

In their exceptions, Protestants Suter take exception to all of the Hearing Officer's conclusions. (Exceptions at 2). In regards to the issues of inclusion of unused water rights, inappropriate expansion of the district, discrepancies in assessed acres, and notice, Protestants rely on their earlier briefing and make no additional argument.<sup>3</sup> For the reasons stated above, Protestants' arguments on these issues are unpersuasive. Accordingly, these exceptions are denied. Protestants submitted additional arguments in support of their exceptions to the Hearing Officer's ruling that there is no legal or factual basis for a claim of injury. However, the arguments are unpersuasive and, for the reasons explained below, these exceptions likewise are denied.

<sup>3</sup> Protestants' except to "the ALJ's findings on all issues". (Exceptions at 2). Inasmuch as the issue of whether issues raised by Protestants after submission of the protest could be considered was decided in Protestants' favor, I do not read their exceptions as including an exception to the ruling on this issue. Furthermore, because Protestants have incorporated their earlier arguments on the issue of inclusion of inundated lands in the petition, and because Protestants' earlier have agreed that the issue is resolved, I do not read their exceptions as including an exception to the ruling on this issue. (Suter Reply at 1).

Protestants begin their argument on injury by re-visiting the issue of ownership of the water right, claiming that the issue of ownership vis-a-vis Protestants as landowners and District patrons, and District is relevant to this proceeding and must be addressed. (Exceptions at 4). While Protestants' argument correctly highlights the issues regarding ownership of a water right within an irrigation district, it fails to explain the relevance of the issue to this hearing. By the plain text of ORS 541.329, Protestants, as users of water within the District have standing to protest the proposed order on Petitioner's 3111 petition and to assert injury to existing water rights. ORS 541.329(5)(d) and 541.331(1). Thus, the issue of ownership need not be addressed in order to resolve this case.

The arguments made by Protestants in support of their exception to the Hearing Officer's conclusion on injury simply reiterate the arguments in Protestants' earlier submissions. Protestants primary argument is that they will be injured because other users within the District who have rights junior to Protestants will receive water rights with priority dates senior to Protestants if the 3111 petition is approved. As discussed above, Protestants fail to make a legally cognizable claim of injury. All of Protestants claims of injury relate to water management within the District. Protestants have not claimed nor made any factual showing that the changes proposed by the 3111 petition will cause them to receive less water than they are legally entitled to at their point of diversion. *See* OAR 690-380-0100(3) (formerly OAR 690-15-005(5), defining injury as a water right not getting the water to which it is legally entitled).

Protestants argument that the injury review for a 3111 petition extends beyond the point of diversion and that the Department has the authority to involve itself in matters concerning how the district delivers water is not supported by any statutory provisions. There is no indication in the text or context of ORS 541.325 to 541.333 that the injury review for a 3111



petition is more expansive than other injury reviews. Moreover, the plain text of related statutes makes it clear that absent a request from users on a shared ditch, the Department's regulatory authority does not extend beyond the point of diversion. ORS 540.045(1)(b) and (c); 540.270.

Notwithstanding Protestants exceptions, I concur with the Hearing Officer's conclusion that Protestants have not made a legal claim of injury; therefore, there is no need for an evidentiary hearing.

### **Conclusions of Law on Contested Case Hearing**

1. Protestants may raise issues in their Statement of Issues for hearing that were not identified in their protest, provided that the issues are reasonably related to a determination of injury resulting from the changes proposed by the District's petition.

2. Protestants claim of injury is outside the scope of the injury evaluation and is a matter of contract and delivery between Protestants and the District. The factual injury issues identified by Protestants therefore, are outside the scope of the injury evaluation and are not relevant to this proceeding. Because Protestants have not made a legally cognizable claim of injury there is no need for an evidentiary hearing.

3. The issue of whether the petition illegally includes water rights from inundated lands and other unused water rights has been resolved by the parties' own admissions.

4. The District's petition complies with the acreage requirements of ORS 541.329(3) and does not inappropriately include land that officially was included in the district in 1994.

Approval of the petition would not result in an impermissible expansion of Petitioner's water right under ORS 541.331(4).

5. The issue of discrepancies between the amount of acres assessed and the amount received by Protestant Suter under the 3111 petition has been resolved, thus there is no need for a hearing on the issue.

6. There is nothing in the record to indicate that the District's notice of the 3111 petition under ORS 541.329 was insufficient. Moreover, Protestants have availed themselves of all of the process to which they are due; thus, any error in the notice would be harmless.

7. The location and survey of the District's right of way is beyond the scope of this hearing and not relevant to a determination of injury under ORS 541.329.

**ORS 541.329 (District Water Rights Mapping) Findings of Fact**

1. On July 1, 1993, pursuant to ORS 541.329 (District Water Rights Mapping), West Extension Irrigation District petitioned the Oregon Water Resources Commission requesting approval and acceptance of district maps showing the location and use of all water rights within the boundaries of the district.

2. West Extension Irrigation District petitioned for approval of the mapping of all or a portion of the following eligible water rights:

- a. The Umatilla River Decree, numbered: Volume 3, Page 127, tabulated in pages 213-215, in the name of Oregon Land and Water Company (now known as West Extension Irrigation District);
- b. The Umatilla River Decree, Volume 15, Page 378, tabulated in pages 436 and 437, in the name of West Extension Irrigation District;
- c. Water Right Certificate 10142 in the name of the United States Reclamation Service of Portland;

- d. Water Right Certificates 26166, 30194, 52732, 52829, 53009, 55596, 55958, 68323; and 75470;
- e. Transfer applications T-3349, T-3525, T-3559, T-3578, T-3597, T-3643, T-3651, T-4033, T-4280, T-4281, T-4282, T-4302 T-4522, T-4523, T-4526, T-4651, T-4652, T-4721, T-4758, T-4759, T-4761, T-4934, T-4975, T-4980, T-4981, T-4993, T-5067, T-5157, T-6327 and T-6959.

3. The water rights allow the use of the waters of the Umatilla River, the Columbia River, wastewater from the West Extension Irrigation District canal, tile drain lines and groundwater for the irrigation and supplemental irrigation of 20,314.49 acres. The Umatilla River Decree, numbered: Volume 3, Page 127, allows domestic use and stock water use, and the Umatilla River Decree, numbered: Volume 15, Page 378, allows stock water use.

4. On June 30, 2000, the Director of the Water Resources Department issued a proposed order, recorded at Special Order Volume 54, Page 720-723, finding West Extension Irrigation District met the requirements of ORS 541.325 to 541.331.

5. The protestants in this matter protested issuance of the proposed order.

6. The petition identifies a change in the place of use and/or type of use for 9,254.8 acres of primary irrigation and 8,614.6 acres of supplemental irrigation, as shown in **Attachment A**.

7. The petition endorses the cancellation of 775.54 acres of water rights. Those rights are listed in **Attachment B**.

8. The petition lists 183.20 acres of water rights to be diminished from primary irrigation to supplemental irrigation. Those rights are listed in **Attachment C**.

9. The Department reviewed the petition and maps submitted by the District, and a report containing the findings is on file at the Department. The Department finds:

- a. West Extension Irrigation District is a “district” as defined in ORS 541.325(1);
- b. The District has met the notice requirements of ORS 541.325(4);
- c. The District filed its petition and maps in a timely manner;
- d. The District paid the fees required under ORS 536.050(1)(m);
- e. The District certified that the notice requirements of ORS 541.329(4) were met;
- f. The District made available for public inspection the proposed order and map for an 120-day period following the first publication of notice under ORS 541.329;
- g. The Department received protests to the proposed order and map within the 60-day period following the first publication of notice under ORS 541.329;
- h. The Department referred the protests to the Office of Administrative Hearings for a contested case hearing;
- i. On June 26, 2001, a prehearing conference was held on the protests;
- j. On July 3, 2001, the Hearing Officer issued an order finding the issues to be resolved at hearing were to be determined through written briefing;
- k. The Hearing Officer issued a proposed order and ruling on legal issues on November 29, 2001;
- l. The District modified the petition consistent with the Proposed Order and Ruling on Legal Issues of the Hearing Officer;
- m. The acreage included in the petition is within the limits of the eligible water rights and the limits set forth in ORS 541.331(4);
- n. The order reflects landowner affidavits requesting water rights appurtenant to their land, or a portion of such rights, be diminished from primary irrigation to supplemental irrigation or canceled;

- o. The content and quality of the District's petition and maps meet the requirements of ORS 541.331(4); and
- p. The changes may be made without injury to existing water rights.

**Conclusions of Law on District Water Rights Mapping**


The West Extension Irrigation District 3111 petition and maps meet the requirements of ORS 541.325 to 541.333.

**Now, therefore, it is Ordered:**

1. The protest in this matter is dismissed.
2. The West Extension Irrigation District petition and maps, as modified to reflect the Ruling on Legal Issues and Proposed Order of the Hearing Officer in the matter of the protest by Pat and Leslie Suter, are approved.
2. The following water right certificates, as recorded in the State Record of Water Right Certificates as 10142, 26166, 30194, 52732, 52829, 53009, 55596, 55598, 68323, and 75470, are canceled.
3. The domestic portion of the right conveyed by the Umatilla River Decrees, recorded at Volume 3, Page 127, and Volume 15, Page 378, is canceled.
4. The Department shall issue confirming water right certificates, conforming to the approved petition, for the irrigation of 9,254.8 acres and the corresponding stock water component of the adjudicated rights, and supplemental irrigation of 8,614.6 acres.
5. New confirming water right certificates issued by the Department shall retain all of the original conditions and limitations upon the rights; such as seasons of use, priority dates, and rate and duty limitations.

6. The Department also shall issue water right certificates describing the remainder of the water right for those portions of the affected rights not altered by the West Extension Irrigation District petition or any other petitioner.
