CORRECTING FINAL ORDER

**Findings of Fact**

1. On March 2, 2016, the Department signed a final order approving Transfer Application T-12220, which was mailed on April 1, 2016. The order was recorded at Special Order Volume 88, Pages 1098-1105.
2. The order contains errors in Findings of Fact #9 and #10. In Finding of Fact #9, the following lands were erroneously included as being authorized places of use for supplemental irrigation under Certificate 79929:

These 3.10 acres are not authorized under Certificate 79929. Thus, the incorrect number of 57.5 acres as the total for authorized places of use under Certificate 79929 subject to T-12220 is corrected to a total of 54.4 acres.

3. In Finding of Fact #10, the following lands located in the SE1/4 SE1/4, Section 13, Township 4 North, Range 25 East, W.M. were incorrectly shown as being proposed places of use for supplemental irrigation under Certificate 79929:

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

The correct acres for the proposed place of use at this location are as follows:

Thus, the incorrect number of 57.5 acres for the total proposed place of use under Certificate 79929 subject to T-12220 is corrected to a total of 54.4 acres.

**Now, therefore, it is ORDERED:**

1. The order approving Transfer Application T-12220, recorded at Special Order Volume 88, Pages 1098-1105, is amended as set forth in Findings of Fact #2 and #3, above.
2. All other provisions of the order recorded at Special Order Volume 88, Pages 1098-1105 are unchanged.
