ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 9395 submitted by

GREG MYERS 380 HODGDON ROAD TILLAMOOK, OREGON 97141.

The right to be modified, as evidenced by Certificate 64853, was perfected under Permit G-9201 with a date of priority of JANUARY 26, 1981. The right allows the use of A WELL, in the FORT ROCK BASIN, for IRRIGATION of 141.9 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.77 cubic feet per second, if available at the original well located at: LOT 4 (NW% NW%), SECTION 2, T 25 S, R 18 E, W.M.; 1320 FEET SOUTH AND 1310 FEET EAST FROM THE NW CORNER, SECTION 2, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The change is temporary. The change shall be effective upon issuance of this order.

- The former place of use shall not be irrigated as part of this water right during the 2003, 2004, 2005, 2006 and 2007 irrigation seasons.
- 3. The use shall revert to the authorized place of use at the end of the 2007 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
