Authority

Oregon Revised Statutes (ORS) 540.570 to 540.580 establish the process in which a district may submit a request to transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

OAR 690-385-6000 establishes that if the water right records show two or more rights as primary on the same land, the right with the oldest priority date shall be considered the primary water right unless the applicant designates a right, other than the right with the oldest priority date, as the primary water right. All other water rights shall be diminished to supplemental water rights.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and request voluntarily cancellation.

Findings of Fact

- 1. On December 26, 2018, Talent Irrigation District (TID) filed a district transfer application to permanently change the place of use under Certificates 79212 and 83727. The Department assigned the application number T-13083.
- 2. Notice of the District Permanent Transfer Application was published on January 1, 2019, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).



- 3. The U.S. Bureau of Reclamation was notified of the transfer application on January 1, 2019; no comments were received within 90 days of the notification.
- 4. On April 10, 2019, TID submitted corrected place of use tables and nine revised maps to correct scrivener's errors on the maps submitted on December 26, 2018.
- 5. On February 27, 2020 and March 30, 2020, TID also submitted revised maps to clarify the OFF place of use.
- 6. The portion of the first right to be transferred is as follows:

The Partial Diminution of Water Right Certificate 15939

- 10. Certain proposed place of use parcels under Certificates 79212 and 83728 will become appurtenant to portions of primary irrigation right Certificate 15939. Therefore, to avoid layering of two primary water rights for irrigation, portions of lands under Certificate 15939 will be diminished to supplemental irrigation as a result of this order.
- 11. On April 10, 2019, the Department received an affidavit from Brooks Downey Newton on behalf of Seven Generations Village, LLC, stating it is the owner of the lands and the appurtenant water right as evidenced by water right Certificate 15939. The affiant has requested the water right for primary irrigation as described below be diminished to supplemental irrigation.

- 12. The Department finds that the district permanent transfer application was submitted according to ORS 540.580 and OAR 690-385-4000, contains the information required under OARs 690-385-4200 and OAR 690-385-2000, and includes maps meeting the requirements of OARs 690-385-4300 and 690-385-2200.
- 13. The Department finds that the proposed district permanent transfer meets all the criteria set forth in ORS 540.580 and OAR 690-385-4000.



- 14. The proposed change in places of use will not result in enlargement of the right as defined in OAR 690-385-0100(4).
- 15. The proposed change in place of use will not result in injury to other water rights as defined in OAR 690-385-0100(6).
- 16. Any other applicable requirements for district permanent water right transfers are met as required in OAR 690-385-4500.

Conclusions of Law

- 1. The proposed changes in place of use as proposed in Transfer Application T-13083 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500.
- 2. The water right for the use of water for primary irrigation on 4.55 acres, as described in Finding of Fact #10 is diminished to use for supplemental irrigation.

Now, therefore, it is ORDERED:

- 1. The proposed changes in place of use to the water rights evidenced by Certificates 79212 and 83727 are approved.
- 2. The diminution of 4.55 acres under Certificate 15939 from primary irrigation to supplemental irrigation is approved.
- 3. The right to the use of the water is restricted to beneficial use at the place of use not modified by this order and is subject to all other conditions and limitations contained in Certificates 79212 and 83727, and any related decree.
- 4. The place of use from which the water right is removed by T-13083 shall no longer be irrigated under the transferred right.
- 5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 6. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2021. A Claim of Beneficial Use shall be submitted by TID to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 7. Water right Certificate 15939 is cancelled. A new certificate will be issued to describe the partial diminution of the right.

8. Water right Certificates 79212 and 83727 are modified. After satisfactory proof of completion has been determined by the Department, superseding confirming-remaining water right certificates will be issued when the Department determines it is necessary for record keeping.
