ORDER APPROVING TRANSFER NO. W-116

On April 8, 1966, C. A. Widmark filed an application in the office of the State Engineer for the approval of a change in place of use of water from Squaw Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Crook County, Oregon, In the Matter of the Relative Rights to the Use of the Waters of Squaw Creek, entered May 1, 1911, a water right was established in the name of E. P. Buchanan for the use of the waters of Squaw Creek for the irrigation of, among other lands, 21-1/3 acres in the SW/4 SE/4, Section 9, Township 15 South, Range 10 East, W.M., with a date of priority of 1883. This right was confirmed by certificate recorded at page 429, Volume 1, State Record of Water Right Certificates, issued in the name of Frank L. Shaw and correcting an error in the Decree.

The applicant herein, owner of the lands above described, proposes to transfer the water right therefrom, without loss of priority, to 21-1/3 acres in the NW/4 SEM, Section 4, Township 15 South, Range 10 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water only.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water is approved and the water right hereinbefore described as appurtenant to 21-1/3 acres in the SW4 SE4, Section 9, Township 15 South, Range 10 East, W.M., with a date of priority of 1883, be severed therefrom and simultaneously and without loss of priority transferred to 21-1/3 acres in the NW4 SE4, Section 4, Township 15 South, Range 10 East, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1967.

It is FURTHER ORDERED that certificate of water right heretofore issued to Frank L. Shaw and recorded at page 429, Volume 1, State Record of Water Right Certificates, is canceled and in lieu thereof a new certificate be issued covering the balance of the lands not involved in this proceeding, and upon receipt of proof satisfactory to the State Engineer of completion of the authorized change in place of use, a certificate of water right shall be issued to C. A. Widmark confirming the extent to which the water has been applied beneficially.
