ORS 540.524 establishes the process in which a water right holder may submit a request to substitute a supplemental water right from a ground water source for a primary water right from a surface water source. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating an application for a water right substitution.

Findings of Fact

- On October 5, 1992 the U.S. Department of the Interior, Bureau of Land Management filed an
 application to substitute supplemental groundwater irrigation use under Certificates 39871 and 47288
 for primary irrigation use under Certificate 39886. The Department assigned the application number
 T-6827. An amended application and map were submitted on April 28, 2003.

5. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.

- 6. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 7. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 8. The proposed change would not result in enlargement of the rights.
- 9. The proposed change would not result in injury to other water rights.

Conclusions of Law

The substitution of a supplemental groundwater right for a primary surface water right proposed in application T-6827 is consistent with the requirements of ORS 540.524, OAR 690-380-2330 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The substitution of a supplemental groundwater right for a primary surface water right proposed in application T-6827 is approved. The listed portion of the primary surface water right under Certificate 39886 shall be treated as a supplemental water right and the listed portions of the supplemental rights under Certificates 39871 and 47288 shall be treated as primary water rights.
- 2. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 39871, 47288, 39886 and any related decree.
- 3. The change shall be effective upon issuance of this order.
- 4. When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 5. The substitution of a supplemental ground water right for a primary surface water right approved under this order may be terminated upon a request by the water right holder or by an order of the Director if the Director determines that the use of the ground water as the primary water right causes injury. Upon termination, the substituted primary and supplemental water rights shall revert to their original status.
