Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7095 submitted by

THE HART INVESTMENT COMPANY P.O. BOX 21 NORTH POWDER, OR 97867

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County as evidenced by a PORTION of Certificate 64203. The decree is recorded in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is 1883.

The right allows the use of POWDER RIVER, a tributary of SNAKE RIVER, for IRRIGATION of 22.8 acres. This right is limited to 0.57 cubic foot per second, if available at the authorized point of diversion: Travillion Koester Ditch, or its equivalent in case of rotation.

The authorized point of diversion is located as follows:

SW¼ NW¼, SECTION 1, TOWNSHIP 7 SOUTH, RANGE 39 EAST, W.M.; 200 FEET NORTH AND 870 FEET EAST FROM THE WEST ¼ CORNER OF SECTION 1.

The amount of water used for irrigation under this right is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

The authorized place of use is located as follows:

NE¼ NW¼ 3.0 ACRES
SE¼ NW¾ 12.8 ACRES
SW¼ NE¼ 7.0 ACRES
