## ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 9013 submitted by

The FIRST right to be modified, was perfected under Permit S-51073 with a date of priority of JUNE 6, 1990. Proof to the satisfaction of the Director that use of water has been accomplished under the terms and conditions of Permit S-51073 has been received. The right allows the use of an UNNAMED STREAM AND A RESERVOIR, to be constructed under Application R-70398, Permit R-11247, tributaries of WEST FORK PALMER CREEK, for IRRIGATION OF 89.9 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.13 cubic feet per second, if available at the authorized point of diversion: SW½ NE½, SECTION 31, T 4 S, R 3 W, W.M.; 660 FEET SOUTH AND 500 FEET EAST FROM NW CORNER, SW½ NE½, SECTION 31,

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

THE USE OF WATER FROM DIRECT FLOW SHALL BE LIMITED TO THE IRRIGATION SEASON PRIOR TO JUNE 1 EACH YEAR.

Proof to the satisfaction of the Director that use of water has been accomplished under the terms and conditions of Permit G-11103 has been received. The right allows the use of ONE WELL in the WEST FORK PALMER CREEK BASIN, for SUPPLEMENTAL IRRIGATION OF 89.9 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not

exceed 1.13 cubic feet per second, if available at the authorized point of diversion: NE% NE%, SECTION 36, T 4 S, R 4 W, W.M.; 100 FEET SOUTH AND 990 FEET EAST FROM NW CORNER, M. JEFFRIES DLC #63, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year. This right shall be limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

- 3. The use shall revert to the authorized place of use at the end of the 2002 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.

5. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
