ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.211, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, PERMIT AMENDMENT T-7737 submitted by

LOST RIVER RANCH
25400 NORTH POE VALLEY ROAD
KLAMATH FALLS, OREGON 97603.

The permit to be modified is Permit G-12442 with a date of priority of AUGUST 23, 1991. The permit allows the use of TWO WELLS, in the LOST RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 1483.0 ACRES. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 18.54 cubic feet per second, if available at the original wells; NW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 26, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 25, T 39 S, R 11 $\frac{1}{2}$ E, W.M.; WELL #1 - SOUTH 41 DEGREES 43 MINUTES 16 SECONDS EAST, 5628 FEET; WELL #2 - SOUTH 58 DEGREES 59 MINUTES 03 SECONDS, 9027 FEET, BOTH FROM THE S 1/16 CORNER BETWEEN SECTIONS 22 AND 23, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be reduced.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation for Well #2 to:

SE¼ SE¼, SECTION 35, T 39 S, R 11½ E, W.M.; 1220 FEET NORTH AND 8 FEET WEST OF SW CORNER, SECTION 35.

THIS CHANGE TO AN EXISTING WATER PERMIT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
2. Water shall be acquired from the same aquifer as the original point of appropriation.
3. All other terms and conditions of the permit remain the same.

Permit G-12442, in the name of LOST RIVER RANCH is amended as described herein.
