## ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8187 submitted by

JACK CORREA 31317 ANDREWS ROAD ECHO, OREGON 97826.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County in the name of John Correa Machado. The decree is recorded in the Order Record of the Water Resources Director in Volume 15, at Page 378. The date of priority is 1900.

The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION of 65.1 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.81 cubic foot per second, subject to the provisions of Paragraph 33 of the decree recorded in the Order Record of the Water Resources Director in Volume 3, Page 127, if available at the authorized point of diversion: SW¼ NE¼, SECTION 21, T 3 N, R 29 E, WM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

These land also have supplemental water rights under Permit 7400 and Certificate 36920. The applicant has provided a statement that says the supplemental rights are not being temporarily transferred and will remain unexercised in the authorized place of use.

The applicant proposes to TEMPORARILY change the place of use, for four years, to:

The applicant has requested the temporary transfer be effective January, 2000.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective January 1, 2000.
- 2. The former place of use shall not be irrigated during the 2000, 2001, 2002, 2003 irrigation seasons.
- 3. The use shall revert to the authorized place of use at the end of the 2003 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.

- 5. The supplemental rights shall remain appurtenant to the land described in the rights, but may not be exercised after January 1, 2000, until the primary right reverts to the original water use. If the primary water right does not revert soon enough to allow use of water under the supplemental rights within five years, the supplemental rights shall become subject to cancellation for non use under ORS 540.610.
- 6. The use of the remaining water rights described by the decree, tabulated in the name of John Correa Machado, Permit 7400, and Certificate 36920, shall continue to be in accordance with the terms and conditions of the decree, Permit 7400, and Certificate 36920.
