Rate & Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second (or its equivalent) and 1.5 acre-feet per acre for each acre irrigated during the period from November 15 to the last day of February of each year, provided further that the right allowed herein be for supplemental irrigation, the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided the total quantity diverted from all sources of supply does not exceed the limitation allowed herein. The use of water during the period from November 15 to the last day of February of each year shall not establish priority of right as against future appropriations for beneficial uses, other than similar rights for irrigation from November 15 to the last day of February.

Certificate: 80652, issued in the name of Chester and Rosalie Prior (Perfected under Permit G-5275)

Use: Supplemental Irrigation of 944.8 acres

Priority Date: March 26, 1974

Rate & Duty: The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The right confirmed herein shall not authorize appropriation from the aquifer supplying these wells within the Butter Creek Water area as finally determined. A totalizing meter shall be maintained on each well prior to making the appropriation.

Transfer Review Criteria (ORS 540.572; 540.570 and 540.580; OAR 690-385)

19. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
20. Diversion structures, district canals, wells, pumps, pump stations, ditches, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights is present.
21. The district temporary transfer application satisfies the criteria of ORS 540.570 and OAR 690-385-3000, contains the information required under OAR 690-385-3200, and includes a map meeting the requirements of OAR 690-385-3300.
22. The proposed changes would not result in injury to other water rights as defined in OAR 690-385-0100(4).
23. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
24. All other applicable requirements for district temporary water right transfers are met.
25. The proposed changes would not result in enlargement of the rights.
26. The proposed changes would not result in injury to other water rights.

Conclusions of Law


The temporary change in place of use proposed in Temporary Transfer Application T-12322 is consistent with the requirements of ORS 540.570 and OAR 690-385-8000.

Now, therefore, it is ORDERED:

1. The temporary changes in place of use as proposed in Transfer Application T-12322 are approved.
2. The former places of use **shall not** be irrigated as part of these water rights during the 2016 irrigation season, except as specifically outlined and described herein.

3. The use shall revert to the authorized place of use at the end of the 2016 irrigation season.
4. A subsequent application for permanent transfer of Certificates 76051, 81815, 80652, 76050, 79439, 76717, 76715, and 76722 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 385. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
5. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 76051, 81815, 80652, 76050, 79439, 76717, 76715, and 76722.
6. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
7. The use of water on the lands from which the water right is transferred, and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
8. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
9. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
10. The use of the remaining water right described by Certificates 76051, 81815, 80652, 76050, 79439, 76717, 76715, and 76722 shall continue to be in accordance with the terms and conditions Certificates 76051, 81815, 80652, 76050, 79439, 76717, 76715, and 76722.
