ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8800 submitted by

CARL F. JENSEN, JR. 3882 BRUSH CREEK DRIVE NE SILVERTON, OREGON 97381.

The right to be modified, as evidenced by a PORTION of Certificate 65140, was perfected under Permit G-10769 with a date of priority of JUNE 25, 1987. The right allows the use of A WELL, in the DRIFT CREEK BASIN, for IRRIGATION OF 16.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 cubic foot per second, if available at the original well; NE% NW%, SECTION 9, T 7 S, R 1 W, W.M.; 1290 FEET SOUTH AND 1340 FEET EAST FROM THE NW CORNER OF SECTION 9, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SW¼ NE¼ 16.5 ACRES SECTION 9

TOWNSHIP 7 SOUTH, RANGE 1 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to TEMPORARILY change the place of use to:

NE¼ SW¼ 12.0 ACRES NW¼ SE¼ 4.5 ACRES SECTION 9

TOWNSHIP 7 SOUTH, RANGE 1 WEST, W.M.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- The former place of use shall not be irrigated as part of this water right during the 2001, 2002, 2003, 2004, and 2005 irrigation seasons.
- 3. The portions of the water right evidenced by Certificate 60352 appurtenant to the proposed place of use, shall not be used during the 2001, 2002, 2003, 2004 and 2005 irrigation seasons.
- 4. The use shall revert to the authorized place of use at the end of the 2005 irrigation season.
- 5. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.

6. The use of the remaining water right described by Certificate 65140 shall continue to be in accordance with the terms and conditions of Certificate 65140.
