Findings of Fact

- 1. Wayne L. Webb and the Oregon Water Trust filed an application to renew L-2, involving all of Certificates 38374, 51048, and 51049 to instream use. The Department assigned the application number L-2.
- 2. The rights to be leased are as follows:

- 3. The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
- 4. The instream use has been modified from the lease application to prevent injury and enlargement and is as follows:

Buck Hollow Creek

Tributary to Deschutes River in the Deschutes Basin

Instream Reach: River Mile 0.8 to 0.0

- 5. A portion of certificates 51048 and 51049 are supplemental to certificate 38374. The supplemental portion of certificates 51048 and 51049 being leased instream shall only be protected instream if the full rate and duty under certificate 38374 are not available during the period for which water is being leased instream. If the supplemental portion is used, up to 0.18 cfs can be allocated on a daily basis until an additional 29.6 acre feet, minus the amount of acre feet already received under the underlying primary portion of certificate 38374 is met.
- 6. Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.
- 7. If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and

Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.

- 8. The lease will commence on April 1, 2007 and terminate on November 1, 2007.
- 9. The lessor has requested the option of terminating the lease early with written notice to the Department.

CONCLUSIONS OF LAW

The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease agreement conforms to the applicable provisions of OAR 690-077-0015.

ORDER

Therefore, it is ORDERED:

- 1. That the Short-Term Lease as described herein is APPROVED.
- 2. The former place of use shall no longer receive water as part of these rights during the term of the lease.
