ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7269 submitted by

TED V. BELL  
3213 WACONDA ROAD  
GERVAIS, OREGON 97026.

The right to be modified, as evidenced by a PORTION of Certificate 34914, was perfected under Permit G-2360 with a date of priority of APRIL 16, 1963. The right allows the use of A WELL, in the WILLAMETTE BASIN, for IRRIGATION OF 12.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 cubic foot per second, if available at the original well; SE $\frac{1}{4}$  SE $\frac{1}{4}$ , AS PROJECTED WITHIN JONES DLC 61, SECTION 1, T 6 S, R 3 W, W.M.; 980 FEET SOUTH AND 600 FEET WEST FROM THE NE CORNER OF JONES DLC 61, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE $\frac{1}{4}$  SE $\frac{1}{4}$  10.0 ACRES  
SE $\frac{1}{4}$  SE $\frac{1}{4}$  2.4 ACRES  
BOTH AS PROJECTED WITHIN JONES DLC 61  
SECTION 1  
TOWNSHIP 6 SOUTH, RANGE 3 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:

NW¼ SW¼, AS PROJECTED WITHIN DLC 50, SECTION 6, T 6 S,  
R 2 W, W.M.; 620 FEET NORTH AND 620 FEET EAST FROM THE NE  
CORNER, JONES DLC 61.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE  
FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1998.
2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 34914 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
