Authority

Oregon Administrative Rules (OAR) 690-380-5140(2) authorizes the Department to grant an extension of time to complete a transfer.

OAR 690-380-6020 establishes an application process and criteria for the review of extensions of time to complete a transfer as authorized by a final order issued under OAR Division 380.

OAR 690-380-6020 (3) establishes that extensions are granted for one year, from October 1 to October 1 of each year. Extensions may be granted for longer time if the applicant can justify the need for a longer period of time by submission of pertinent evidence.

Findings of Fact

- 1. On January 4, 2008, the Department received an application for extension of time for Transfer Application T-10517.
- 2. On July 1, 2008, the Department signed an order, which was mailed on July 8, 2008, approving Transfer Application T-10517 to change places of use and add additional points of appropriation. The order was recorded in Special Order Volume 75-, Pages 304-309. The order set a transfer completion date of October 1, 2009. On September 30, 2010, the Department signed a correcting order, which was mailed on October 4, 2010, to correct the rate associated with Certificate 76368.
- 3. Since the approval of the transfer, the applicant has irrigated 480.3 acres out of the proposed 438.8 acres. Due to limited allocations, some corners have not yet been irrigated.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 4. To fully complete the change, the applicant needs to irrigate 8.5 acres The applicant plans to utilize a traveling big gun and wheel lines to irrigate the remaining corners.
- 5. The applicant has requested that the time for completion of beneficial use be extended to October 1, 2022. Consistent with OAR 690-380-6020(3), the Department will extend the transfer completion date to October 1, 2022.

Conclusions of Law

Pursuant to OAR 690-380-6020, the Director of the Water Resources Department concludes the applicant has shown reasonable diligence to complete the transfer within the time period established by the order approving Transfer Application T-10517.

Now, therefore, it is ORDERED:

The time for completion of the changes authorized by Transfer Application T-10517 shall be extended to **October 1, 2022.**
