ORDER APPROVING CHANGES IN PLACE OF USE  
AND POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7978 submitted by

The right to be modified, as evidenced by Certificate 54693, was perfected under Permit G-9078 with a date of priority of DECEMBER 2, 1980. The right allows the use of A WELL, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 135.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.69 cubic feet per second, if available at the original well; NE $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 19, T 27 S, R 17 E, W.M.; 1320 feet SOUTH and 1280 feet WEST from the NE CORNER, SECTION 19, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The applicant proposes to change the point of appropriation to:

SE $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 31, T 26 S, R 17 E, W.M.; 1323 feet SOUTH and 1234 feet EAST from the NW CORNER of SECTION 31.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 1999.
2. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 54693 is cancelled.. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
