Findings of Fact

Background

- 1. On June 8, 2009, the Department issued an order approving changes in place of use and points of diversion associated with Transfer Application T-6783. This order is recorded at Special Order Volume 78, Pages 48 65.
- 2. Page 17 of 18 of the Final Order recorded at Special Order Volume 78, Pages 48 65, listed several water right certificates to be canceled as follows:

Now, therefore it is ORDERED:

- 1. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 52677, 52678, 52679, 52680, 68760, 68761, 68762, 68763 and 72649 and any related decree.
- 2. Certificates 52677, 52678, 52679, 52680, 68760, 68761, 68762, 68763 and 72649 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 3. A scrivener's error in the first two conditions on Page 17 of 18 of the Final Order recorded at Special Order Volume 78, Pages 48 65, misidentified one of the water right certificates affected by the transfer. The misidentified water right certificate was number 72649. The correct certificate number is 76249.
- 4. The Final Order recorded at Special Order Volume 78, Pages 48 65, Finding of Fact #11, describes the proposed place of use for the rights affected by the transfer. The listing included erroneous acres for certificates 52678 and 52679 in the NW NW, T4N, R28E, Section 34. The Final Order described the proposed place of use as follows:

- 3. All other provisions of the Final Order approving transfer application T-6783, recorded at Special Order Volume 78, pages 48 65, remain unchanged.
