ORDER APPROVING CHANGES IN PLACE OF USE AND POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7972 submitted by

STAN ADAMS P.O. BOX 806 CHRISTMAS VALLEY, OREGON 97641

The first right to be modified, as evidenced by a PORTION of Certificate 37388, was perfected under Permit U-648 with a date of priority of JULY 28, 1954. The right allows the use of WEI L 1, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 8.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 cubic foot per second, if available at the original well; NE½ SW½, SECTION 34, T 27 S, R 16 E, W.M.; WELL 1 - 32 feet SOUTH and 36 feet EAST from the NW CORNER of the NE½ SW¼, SECTION 34., or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE¼ SW¼ 8.4 ACRES SECTION 34 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:

SE¼ SW¼, SECTION 12, T 27 S, R 16 E, W.M.; 1325 feet SOUTH and 1349 feet EAST from the W¼ CORNER, SECTION 12.

The second right to be modified, as evidenced by a PORTION of Certificate 46881, was perfected under Permit G-5512 with a date of priority of JANUARY 12, 1972. The right allows the use of WELL 1, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 16.7 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.21 cubic foot per second, if available at the original well; NE¼ SW¼, SECTION 34, T 27 S, R 16 E, W.M.; WELL 1 - 32 feet SOUTH and 36 feet EAST from the NW CORNER of the NE¼ SW¼, SECTION 34., or its equivalent in case of rotation, measured at the well.

The authorized place of use is as follows:

NE¼ SW¼ 0.2 ACRES SE¼ SW¼ 0.1 ACRES NE¼ SE¼ 8.2 ACRES NW¼ SE¼ 8.2 ACRES SECTION 34 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the place of use to:

NE¼ SW¼ 16.7 ACRES SECTION 12 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the point of appropriation to:

SE½ SW½, SECTION 12, T 27 S, R 16 E, W.M.; 1325 feet SOUTH and 1349 feet EAST from the W½ CORNER, SECTION 12.

The third right to be modified, as evidenced by a PORTION of Certificate 54690, was perfected under Permit G-7364 with a date of priority of FEBRUARY 9, 1977. The right allows the use of 2 WELLS, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 8.1 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.101 cubic foot per second being 0.034 cfs from WELL 1 and 0.067 cfs from WELL 2, if available at the original wells; NE½ SW¼, SW¼ SE¼, SECTION 34, T 27 S, R 16 E, W.M.; WELL 1 - 30 feet SOUTH and 1360 feet EAST from the W½ CORNER, WELL 2 - 1230 feet NORTH and 2000 feet WEST from the SE CORNER, both SECTION 34, or its equivalent in case of rotation, measured at the well.

The authorized place of use is as follows:

NW¼ SW¼ 1.2 ACRES
SW¼ SW¼ 2.2 ACRES
SE¼ SW¼ 2.8 ACRES
SW¼ SE¼ 1.0 ACRES
SE¼ SE¼ 0.9 ACRES
SECTION 34
TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the place of use only for 0.4 ACRES to:

NW¼ SW¼ 0.4 ACRES SECTION 34 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant is not moving the point of appropriation for the 0.4 ACRES tabulated above. 0.005 cfs remains with WELL 1 and WELL 2, being 0.002 cfs from WELL 1 and 0.003 cfs from WELL 2.

The applicant proposes to change the place of use for the remaining 7.7 ACRES to:

NW¼ SW¼ 7.7 ACRES SECTION 12 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the point of appropriation for the remaining 7.7 ACRES, being 0.096 cfs to:

SE¼ SW¼, SECTION 12, T 27 S, R 16 E, W.M.; 1325 feet SOUTH and 1349 feet EAST from the W¼ CORNER, SECTION 12.

The fourth right to be modified, as evidenced by a PORTION of Certificate 52641, was perfected under Permit G-8201 with a date of priority of MAY 19, 1978. The right allows the use of WELL 3, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 19.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.25 cubic foot per second, if available at the original well; SW¹/₄ NE¹/₄, SECTION 34, T 27 S, R 16 E, W.M.; WELL 3 - 1350 feet SOUTH and 1350 feet WEST from the NE CORNER, SECTION 34, or its equivalent in case of rotation, measured at the well.

The authorized place of use is as follows:

NE¼ NE¼ 3.2 ACRES NW¼ NE¼ 2.8 ACRES SW¼ NE¼ 1.8 ACRES SE¼ NE¼ 2.2 ACRES NE¼ NW¼ 9.5 ACRES SECTION 34 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the place of use only for 7.4 ACRES to:

NW¼ NE¼ 3.7 ACRES SW¼ NE¼ 3.7 ACRES SECTION 34 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant is not moving the point of appropriation for the 7.4 ACRES tabulated above. 0.10 cfs remains with WELL 3.

The applicant proposes to change the place of use for the remaining 12.1 ACRES to:

NE¼ SW¼ 4.7 ACRES NW¼ SW¼ 7.4 ACRES SECTION 12 TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the point of appropriation for the remaining 12.1 ACRES, being 0.15 cfs to:

SE¼ SW¼, SECTION 12, T 27 S, R 16 E, W.M.; 1325 feet SOUTH and 1349 feet EAST from the W¼ CORNER, SECTION 12.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed changes shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water available from the original points of appropriation.
- 3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original points of appropriation.
- 5. The former places of use shall no longer be irrigated as part of these water rights.

Certificates 37388, 46881, 54690 and 52641 are canceled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed changes are received, new certificates confirming these water rights will be issued.
