On April 23, 1945, George Coombs, Star Route, Redmond, Oregon, filed an application for the approval of a change in place of use of water from Squaw Creek.

By an order dated May 17, 1937, the State Engineer approved an application of the World War Veterans' State Aid Commission for a change in place of use of water from Squaw Creek wherein certain water rights awarded the Squaw Creek Irrigation Company in the Squaw Creek Adjudication Proceedings were transferred to, among other lands, 40 acres in the SE4 NE4, Section 6, Township 15 South, Range 11 East, W. M., of which 26 acres have a date of priority of November 11, 1895, and 14 acres have a date of priority of 1895.

The applicant herein, owner of the above-described land, proposes to transfer the water right appurtenant thereto to 26 acres in the $NE_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$, Section 32, Township 14 South, Range 11 East, W. M., with a date of priority of November 11, 1895, and 10 acres in the $SE_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$, Section 32, and 4 acres in the $NW_4^{\frac{1}{4}}$ $NW_4^{\frac{1}{4}}$, Section 33, Township 14 South, Range 11 East, W. M., with a date of priority of 1895.

Notice by publication as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required on applications for only a change in place of use of water.

All the lands involved herein are within the boundaries of the Squaw Creek Irrigation District.

The Squaw Creek Irrigation District, through its secretary, has approved the proposed change in place of use of water, and it appearing that the proposed change may be made without injury to existing rights, the application should be approved.

Mr. Walter Coombs who holds a mortgage on the lands from which it is proposed to transfer the water has submitted his written approval of the application.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water be and the same hereby is approved, and the water rights hereinbefore described as appurtenent to 40 acres in the SE_4^1 NE_4^1 , Section 6, Township 15 South, Range 11 East, W. M., of which 26 acres have a date of priority of November 11, 1895, and 14 acres have a date of priority of 1895, be severed therefrom and simultaneously and without loss of priority be transferred to 26 acres in the NE_4^1 NE_4^1 , Section 32, Township 14 South, Range 11 East, W. M., with a date of priority of November 11, 1895, and 10 acres in the SE_4^1 NE_4^1 , Section 32, and 4 acres in the NW_4^1 NW_4^1 , Section 33, Township 14 South, Range 11 East, W. M., with a date of priority of 1895.

It is FURTHER ORDERED that the water so transferred shall be applied to beneficial use on the lands to which it is hereby transferred on or before October 1, 1946, or such extension of time as may be granted by the State Engineer for good cause shown.
