## ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7553 submitted by

STEPHEN AND DENISE IFFT 7841 HOWELL PRAIRIE ROAD SILVERTON, OREGON 97381.

The first right to be modified, as evidenced by a PORTION of Certificate 31799, was perfected under Permit G-1572 with a date of priority of APRIL 11, 1960. The right allows the use of A WELL, in the PUDDING RIVER BASIN, for IRRIGATION OF 5.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.04 cubic foot per second, if available at the original well; NE½ SW½, AS PROJECTED WITHIN HEADRICK DLC 44, SECTION 24, T 6 S, R 2 W, W.M.; 12.5 CHAINS SOUTH AND 40.5 CHAINS WEST FROM THE E½ CORNER OF SECTION 24, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The second right to be modified, as evidenced by a PORTION of Certificate 40219, was perfected under Permit G-4495 with a date of priority of JANUARY 24, 1969. The right allows the use of A WELL, in the PUDDING RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 5.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.02 cubic foot per second, if available at the original well; NE% SW%, AS PROJECTED WITHIN HEADRICK DLC 44, SECTION 24, T 6 S, R 2 W, W.M.; 12.5 CHAINS SOUTH AND 40.5 CHAINS WEST FROM THE E% CORNER OF SECTION 24, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NW¼ SE¼ 5.0 ACRES
AS PROJECTED WITHIN HEADRICK DLC 44
SECTION 24
TOWNSHIP 6 SOUTH, RANGE 2 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:

NW% SE%, AS PROJECTED WITHIN HEADRICK DLC 44, SECTION 24, T 6 S, R 2 W, W.M.; 10.5 CHAINS SOUTH AND 28 CHAINS WEST FROM THE E% CORNER OF SECTION 24.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificates 31799 AND 40219 are cancelled. New certificates will be issued to confirm those portions of these rights NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
