**Authority**

Oregon Revised Statute (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to temporarily transfer the place of use and, if necessary to convey the water to the temporary place of use, the point of diversion authorized under an existing water right.

Oregon Administrative Rule (OAR) Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

**Findings of Fact**


1. On June 15, 2017, LANCEFIELD FARM COMPANY, TOM LANCEFIELD filed an application to temporarily change the place of use under Certificate 42573 for a period of five years. The Department assigned the application number T-12694.
2. On August 14, 2017, the Water Resources Department issued an order approving Temporary Transfer Application T-12694. The order was recorded in Special Order Volume 105, Pages 594-597.
3. Under the order, the water right would revert to the authorized place of use at the end of the 2021 irrigation season.
4. The most recent use of water at the place of use authorized under the temporary transfer was during the 2020 irrigation season.
5. On November 2, 2020, LANCEFIELD FARM COMPANY, TOM LANCEFIELD, the applicant, submitted a written request via e-mail, requesting Temporary Transfer T-12694 be voluntarily terminated.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Now, therefore, it is ORDERED:**

Temporary Transfer T-12694 is terminated. The use shall revert to the place of use authorized under Certificate 42573. Water may not be used at the authorized place of use during the same season in which water was used under the Temporary Transfer.
