O R D E R

Now, at this time, this matter coming on for the consideration of the State Engineer, and it appearing that the holders of the following permits to appropriate water have failed to submit annual proof of construction work and the use of water under their respective permits, and that letters have been addressed to the holders of said permits by registered mail in accordance with the provisions of Section 5774, Oregon Laws, notifying them that unless proper showing of good faith and due diligence was made within sixty days from the date of such notice, their permits would be cancelled and that said holders of these permits have failed to submit any statement or response whatever to said registered notice concerning the prosecution of work under said permits, although the sixty-day time limit has elapsed:
