FINAL ORDER APPROVING A CHANGE IN PLACE OF USE

Authority

Oregon Revised Statute (ORS) 537.211 establishes the process in which a water right permit holder may submit a request to change the point of appropriation and/or place of use authorized under an existing water right permit.

Findings of Fact

- 1. On October 17, 2016, Domain Drouhin Oregon filed an application to change the place of use under Permit G-11362 and Permit G-12080. The Department assigned the application number T-12506.
- 2. On January 6, 2014, the Department approved assignments of the permits to Domaine Drouhin Oregon.
- 3. On July 25, 2014 the Department approved extensions of time of the permits for complete application of water to October 1, 2022.
- 4. The application contains information that better describes the authorized points of appropriation for Permit G-12080 as being located at:

Permit Amendment Review Criteria

- 8. The changes would not result in injury to other water rights.
- 9. The proposed place of use is owned and/or controlled by the permit holder.
- 10. The changes do not enlarge the permits.

- 11. The changes do not alter any other terms of the permits.
- 12. The proposed place of use is contiguous to the authorized place of use.

Conclusions of Law

The change in place of use proposed by Permit Amendment Application T-12506 is consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

- 1. The change in place of use proposed by Permit Amendment Application T-12506 is approved.
- 2. Permit G-17740 and Permit G-17741, in the name of Domaine Drouhin Oregon, are issued to replace Permit G-11362 and Permit G-12080, and incorporates the amendments approved by this order, the extension of time and the assignment. Permit G-11362 and Permit G-12080, in the name of Domaine Drouhin Oregon are no longer of any force or effect.
- 3. The former place of use shall no longer be irrigated as part of these permits.
- 4. All other terms and conditions of Permit G-17740 and Permit G-17741 remain the same.
