Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On December 12, 2008, the United States Bureau of Land Management (BLM) filed an application to change the point of diversion under Certificates 9451, 22209, and 45409. The Department assigned the application number T-10750.
- 2. On March 24, 2007, the applicant submitted a revised map, identifying acreage for transfer.
- 3. On March 31, 2009, the applicant requested under OAR 690-380-3100(E) approval of the use of the scale 1"=2000' for the mapping. The request was approved.
- 4. On April 1, 2009, the applicant requested more time to complete beneficial use with the new point of diversion because of weather and lake levels. The reasoning for the extended time request is because the lake does not fill every year. The request for more time (until October 1, 2014) was approved.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

acre irrigated during the irrigation season of each year.

- 9. Certificate 9451 contains a scrivener's error, being that the sum of water right acres listed for Tract 4 in the certificate equals 5,033.1 acres, rather than the 4993.1 acres stated in the opening paragraph of the certificate's text.
- 10. Certificate 9451 describes the authorized place of use for 35.35 acres in the Lot 4 (NE¼ SW¼) of Section 1, and 36.05 acres in Lot 1 (NE¼ NW¼), Section 12, Township 36 South, Range 24 East, W. M, Lake County, Oregon.
 - a. The transfer application depicts the place of use under Certificate 9451 as being 35.25 acres in the Lot 4 (NE¼ SW¼) of Section 1, and 35.05 acres in Lot 1 (NE¼ NW¼), Section 12, Township 36 South, Range 24 East, W.M.
 - b. It appears that the place of use depicted in the 1916 survey and the transfer map are the same area on the ground. Though the footprint is the same, use of current technology to measure the area results in a slightly different quantification of acreage. This leads the Department to conclude that the land to which the right has always been appurtenant should be re-described.

c. The following table lists the place of use as described in existing Certificate 9451 and a proposed re-description based on the above findings:

- 11. The apparent 1.10 acre loss between the original description and the re-description does not represent a reduction in actual land area to which the water right is appurtenant, but is simply an adjustment of the water right record to more accurately reflect the reality on the ground. Future certificates issued for this portion of the water right will be based on this redescription.
- 12. The place of use description in Certificate 9451 does not include Government Lots, however, the true legal description of the land to which the water right is appurtenant is based on Government Lots. Therefore, the place of use of the transferred portion of the right will be re-described as follows:

- 15. Certificate 22209 does not describe the distance of the point of diversion from survey corners, however information is available from the water right map indicating that the point of diversion is located as follows:

- 17. Certificate 22209 describes the authorized place of use for 35.35 acres in the Lot 4 (NE¼ SW¼) of Section 1, 36.05 acres in Lot 1 (NE¼ NW¼), Section 12, Township 36 South, Range 24 East, W. M., and 40.20 acres in the SW¼ SW¼, Section 7, Township 36 South, Range 25 East, W.M., Lake County, Oregon.
 - a. The transfer application depicts the place of use under Certificate 22209 as being 35.25 acres in the Lot 4 (NE½ SW½) of Section 1, 35.05 acres in Lot 1 (NE½ NW¼), Section 12, Township 36 South, Range 24 East, W. M., and 40.02 acres in the SW¼ SW¼, Section 7, Township 36 South, Range 25 East, W.M.
 - b. It appears that the place of use depicted in the 1916 survey and the transfer map are the same area on the ground. Although the footprint is the same, the use of current technology to measure the area results in a slightly different quantification of acreage. This leads the Department to conclude that the land to which the right has always been appurtenant should be re-described.
 - c. The following table lists the place of use as described in existing Certificate 22209 and a proposed re-description based on the above findings:

- 18. The apparent 1.28 acre loss between the original description and the re-description does not represent a reduction in actual land area to which the water right is appurtenant, but is simply an adjustment of the water right record to more accurately reflect the reality on the ground. Future certificates issued for this portion of the water right will be based on this redescription.
- 19. The place of use description in Certificate 22209 includes Government Lots in the description of the right in some sections, but not consistently throughout the place of use table. Since the true legal description of the land to which the water right is appurtenant is based on Government Lots, therefore, the place of use of the transferred portion of the right will be re-described as follows:

The apparent 1.1 acre loss between the original description and the re-description does not represent a reduction in actual land area to which the water right is appurtenant, but is simply an adjustment of the water right record to more accurately reflect the reality on the ground. Future certificates issued for this portion of the water right will be based on this redescription.
- 26. The place of use description in Certificate 45409 includes Government Lots in the description of the right in all sections where applicable, but for purposes of the water right records, which are organized primarily by ½ ½ Sections, and to standardize the descriptions of rights appurtenant to the same lands, when a confirming certificate is issued for the place of use involved in the transfer, it will be described as follows:

- 27. Notice of the application for transfer was published on December 30, 2008, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 28. On April 1, 2009, the Department emailed a copy of the *draft* Preliminary Determination proposing to approve Transfer Application T- 10750 to the applicant. The *draft* Preliminary Determination set forth a deadline of May 1, 2009, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and on April 21, 2009, the Water Resources Department received a preliminary title report provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 29. On July 21, 2009, the Department issued a Preliminary Determination proposing to approve Transfer Application T-10750 and mailed a copy to the applicant. An incomplete protest was received and returned to the protestant.
- 30. On August 27, 2009, the Department received two affidavits asserting non-use under ORS 540.610 of a portion of the water rights proposed for transfer.
- 31. On October 15, 2009, the Department initiated cancellation proceedings pursuant to ORS 540.610 by issuing Notices of Proposed Partial Cancellation of water rights for a portion of the water rights proposed for transfer.
- 32. On October 19, 2009, following Notices of Proposed Partial Cancellation, the Department issued an order recorded at Special Order Volume 79, Pages 38 to 39, withdrawing the Preliminary Determination. The order stated the Department shall issue a revised Preliminary Determination consistent with the outcome of the ORS 540.610 cancellation proceeding.
- 33. A cancellation hearing (OAH Ref. No: WR-10-001) was held December 13 through December 17, 2010, before Administrative Law Judge (ALJ) Allen of the Oregon Office of Administrative Hearings.
- 34. On March 31, 2011, ALJ Allen issued a Proposed Order finding the BLM has not failed to beneficially use water on the contested acres for a period of five or more years during the period in issue and no portion of the water rights evidenced by Certificates 9451, 22209 and 45409 has been forfeited due to non-use during the period in issue.
- 35. On April 5, 2011, ALJ Allen issued a Corrected Proposed Order because the order was issued without required exceptions language.

- 36. On November 14, 2011, the Department issued an Amended Corrected Proposed Order consistent with that of ALJ Allen.
- 37. On April 20, 2012, The Water Resources Commission (WRC) issued a Final Order, after hearing exceptions and responses to exceptions filed by the Proponent and Protestants, adopting the Amended Corrected Proposed Order. The Final Order of the WRC states the United State Bureau of Land Management has not failed to beneficially use water on the contested acres for a period of five or more consecutive years during the period in issue and no portion of the water rights evidenced by Certificates 9451, 22209 and 45409 has been forfeited due to non-use during the period in issue.
- 38. On April 26, 2012, the Department issued a revised Preliminary Determination proposing to approve Transfer Application T-10750 and mailed a copy to the applicant(s). Additionally, notice of the revised Preliminary Determination for the transfer application was published on the Department's weekly notice on May 1, 2012, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 39. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is currently equipped with an appropriate fish screening and/or by-pass device.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 40. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 41. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Application T-10750.
- 42. The proposed change would not result in enlargement of the rights.
- 43. The proposed change would not result in injury to other water rights.

Conclusions of Law

The change in point of diversion proposed in application T-10750 is consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. The application is approved pursuant to the terms and conditions below.

Now, therefore, it is ORDERED:

1. The change in point of diversion proposed in application T-10750 is approved.

- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 9451, 22209, and 45409 and any related decree.
- 3. Water right certificates 9451, 22209, and 45409 are cancelled. New certificates will be issued describing the portions of the rights not affected by this transfer.
- 4. The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
- 5. The water user shall maintain and operate a fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.
- 6. Water use measurement conditions:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at the point of diversion.
 - b. The water user shall maintain the meter or measuring device in good working order.
 - c. The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.
- 7. Prior to diverting water, the water user shall install a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain the headgate as required by the Department.
- 8. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2014**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 9. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
