ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 7980 submitted by

POTLATCH CORPORATION P.O. BOX 38 BOARDMAN, OREGON 97818.

The right to be modified, as evidenced by a portion of Certificate 74193, was perfected under Permit 36940 with a date of priority of JUNE 29, 1973. The right allows the use of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION of 3.7 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.09 cubic foot per second, if available at the authorized point of diversion: LOT 7 (NE¼ NW¼) SECTION 2, T 4 N, R 25 E, WM; S 86° 22' 46" WEST, 2811 FEET FROM THE NE CORNER, SECTION 2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acrefeet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE% NE% 3.7 ACRES
SECTION 23
TOWNSHIP 4 NORTH, RANGE 26 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant's certified Water Right Examiner (CWRE) has provided information that the description of the authorized point of diversion is incorrect. The CWRE has determined, using GPS surveying methods, that the authorized point of diversion is located as follows:

LOT 2 (NE% NW%), SECTION 2, T 4 N, R 25 E, WM; S 86° 22' 46" W, 2829 FEET FROM THE NE CORNER, SECTION 2.

The applicant proposes to TEMPORARILY change the place of use to:

SE% SE% 3.7 ACRES
SECTION 27
TOWNSHIP 4 NORTH, RANGE 26 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former place of use shall not be irrigated as part of this water right during the 1998 irrigation season.
- 3. The use shall revert to the authorized place of use at the end of the 1998 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water right described by Certificate 74193 shall continue to be in accordance with the terms and conditions of Certificate 74193.
