**FINDINGS OF FACT**

1. A Short-Term Lease Application, which proposed to lease all or a portion of certificates 76358 & 76714 for instream purposes was submitted to the Department by:

2. The instream lease application included the required fees. The Department assigned this lease agreement number L-567.
3. The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
4. The rights to be leased, as requested by the applicant, are as follows:

**Certificate:** 76358

**Use:** Irrigation

**Acres:** 12.3 acres

**Priority Date:** October 31, 1900 & December 2, 1907

**Season of Use:** April 1 through October 31, further limited as follows:

April 1 to May 1 and October 1 to November 1 described herein as  
Season 1

May 1 to May 15 and September 15 to October 1 described herein as  
Season 2

May 15 to September 15 described herein as Season 3

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

**Quantity:** Season 1 (limited to 1/80<sup>th</sup> Cubic Foot per Second (CFS) per acre): 0.15 CFS  
 Season 2 (limited to 1/60<sup>th</sup> cfs per acre): 0.21 CFS  
 Season 3 (limited to 1/32.4<sup>th</sup> cfs per acre): 0.38 CFS  
 Duty (limited to 9.91 acre-feet per acre): 121.9 Acre-Feet (AF)  
 The quantities listed reflect allowance of a 45% transmission loss as determined by decree of the Circuit Court of Deschutes County, dated March 24, 1933.

**Authorized Place of Use:** Same as described for certificate 76358.

- The Department finds that the lease application requires modification in order to clarify the amount of water allowed under each priority date associated with the primary right, certificate 76358. In addition, the supplemental right requires clarification to identify the amount of water that may be leased and to clarify the source of water. The rights are clarified as follows (changes are shown in bold text):

**Use:** Irrigation

**Acres:** 12.3 acres  
**Priority Date:** October 31, 1900 & December 2, 1907  
**Season of Use:** April 1 through October 31, further limited as follows:  
 April 1 to May 1 and October 1 to November 1 described herein as Season 1  
 May 1 to May 15 and September 15 to October 1 described herein as Season 2  
 May 15 to September 15 described herein as Season 3  
**Quantity:** Season 1 (limited to 1/80<sup>th</sup> CFS per acre): 0.15 CFS  
 Season 2 (limited to 1/60<sup>th</sup> CFS per acre): 0.21 CFS  
 Season 3 (limited to 1/32.4<sup>th</sup> CFS per acre): **0.38 CFS, being 0.27 CFS under the 1900 priority date and 0.11 CFS under the 1907 priority date**  
 Duty (limited to 9.91 acre-feet per acre): 121.9 AF  
 The quantities listed reflect allowance of a 45% transmission loss as determined by decree of the Circuit Court of Deschutes County, dated March 24, 1933.  
**Source:** Deschutes River, tributary to the Columbia River  
**Certificate:** 76714  
**Use:** Irrigation  
**Acres:** 12.3 acres  
**Priority Date:** February 28, 1913  
**Season of Use:** April 1 through October 31  
**Quantity:** **11.94 AF.** This right does not have a rate limitation. This volume is based upon evenly distributing each acre-foot stored in Crane Prairie Reservoir, 50,000 af, under this certificate between the 51,536.847 acres to which water may be applied. The distribution per acre is 0.97 af per acre.  
**Source:** Crane Prairie Reservoir, tributary to the **Deschutes** River

6. The application proposes to lease water for instream as follows:

Reach: From the COID North Canal POD (11) (SE NE, Section 29, T17S, R12E, W.M., 850 Feet North and 630 Feet West from the E 1/4 Corner, Section 29) on the Deschutes River to Lake Billy Chinook.

7. The Department finds that in order to prevent injury and enlargement the applicant's request must be modified. Clarification of the rate at which water is to be leased instream by priority date as well as the total volume for the primary right is necessary. In addition, the amount of

water that may be leased instream under the supplemental right needs some clarification. Therefore, the Department finds that water may be leased instream as follows (changes are shown in bold text):

Reach: From the COID North Canal POD (11) (SE NE, Section 29, T17S, R12E, W.M., 850 Feet North and 630 Feet West from the E 1/4 Corner, Section 29) on the Deschutes River to Lake Billy Chinook.

8. To prevent injury an enlargement, the amount of water to be leased instream under certificate 76358 accounts for a 45% transmission loss that may not be leased and protected instream.
9. Certificate 76714 is supplemental to certificate 76358. The portion of certificate 76714 being leased instream shall only be protected instream if the full rate and duty under certificate 76358 are not available during the period for which water is being leased instream.
10. Based upon review of the application and information provided by the Department's Watermaster, the Department finds that the lease, as modified, will not result in injury or enlargement.
11. The lease will terminate on October 31, 2008. The Lessors and Lessee have requested the option of terminating the lease early with written notice to the Department.

### CONCLUSIONS OF LAW

The Department concludes that the lease, as modified above, will not result in injury or enlargement, OAR 690-077-0077:

**ORDER**

Therefore, it is ORDERED:


1. That the Short-Term Lease described herein is APPROVED.
2. The authorized place of use shall not be irrigated during the term of this lease.
3. Water is leased instream as follows:

Reach: From the COID North Canal POD (11) (SE NE, Section 29, T17S, R12E, W.M., 850 Feet North and 630 Feet West from the E 1/4 Corner, Section 29) on the Deschutes River to Lake Billy Chinook.

4. Certificate 76714 is supplemental to certificate 76358. The portion of certificate 76714 being leased instream shall only be protected instream if the full rate and duty under certificate 76358 are not available during the period for which water is being leased instream.
5. The lease will terminate on October 31, 2008. The Lessor shall have the option of terminating the lease each year, prior to the lease being exercised (April 1), with 30 day written notice to the Department.
