ORDER APPROVING CHANGES IN USE AND PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8066 submitted by

GERTRUDE M. JOHNSON  
77876 STABLE LANE  
HERMISTON, OREGON 97838.

The right to be modified, as evidenced by a PORTION of Certificate 44655, was perfected under Permit G-4171 with a date of priority of JUNE 3, 1968. The right allows the use of A WELL, in the UMATILLA RIVER BASIN, for IRRIGATION OF 22.7 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.24 cubic foot per second, if available at the original well; NE $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 25, T 4 N, R 27 E, W.M.; 450 FEET SOUTH AND 850 FEET WEST FROM THE E $\frac{1}{4}$  CORNER, SECTION 25, or its equivalent in case of rotation, measured at the well.

**This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).**

**Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.**

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE $\frac{1}{4}$ SE $\frac{1}{4}$	1.72 ACRES
SW $\frac{1}{4}$ SE $\frac{1}{4}$	4.57 ACRES
SE $\frac{1}{4}$ SE $\frac{1}{4}$	16.41 ACRES

SECTION 25

TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the use to COMMERCIAL USE.

The applicant also proposes to change the place of use:

SE $\frac{1}{4}$

SECTION 25

TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.

The applicant also proposes to change the season of use to YEAR ROUND use.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2005.


2. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
3. The former place of use shall no longer be irrigated as part of this water right.
4. The amount of water used for commercial use, together with the amount secured under any other right existing on the same lands, is limited to 0.24 cubic foot per second, or its equivalent, and shall be further limited to a diversion of not to exceed 68.1 acre-feet during the calendar year.

Certificate 44655 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed changes is received, a new certificate confirming this water right will be issued.
