**Findings of Fact**

1. On December 3, 2015, the Department issued an order approving Transfer Application T-11929. The order was recorded at Special Order Volume 98, Pages 411-417.
2. The order contained a scrivener's error in the location description of the proposed additional points of appropriation for the right described by Certificates 55555.
3. The erroneous description of the proposed additional points of appropriation is as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
19 S	46 E	WM	21	SE SW	WELL 1 – 1160 FEET SOUTH AND 2480 FEET EAST FROM THE NW CORNER OF SECTION 21.
19 S	46 E	WM	21	NW SW	WELL 6 – 1080 FEET SOUTH AND 2430 FEET EAST FROM THE NW CORNER OF SECTION 21

4. The correct description (**bold type**) of the proposed additional points of appropriation is as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
19 S	46 E	WM	21	<b>NE NW</b>	WELL 1 – 1160 FEET SOUTH AND 2480 FEET EAST FROM THE NW CORNER OF SECTION 21.
19 S	46 E	WM	21	<b>NE NW</b>	WELL 6 – 1080 FEET SOUTH AND 2430 FEET EAST FROM THE NW CORNER OF SECTION 21

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Now, therefore, it is ORDERED:**

1. The order approving Transfer Application T-11929 as recorded in Special Order Volume 98, Pages 411-417 is corrected to describe the correct locations of the proposed additional points of appropriation for the right described by Certificates 55555.
2. All other provisions of Special Order Volume 98, Pages 411-417 remain in effect.
