## ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6794 submitted by

GRAND ISLAND LLC 17610 SE 46<sup>TH</sup> PLACE BELLEVUE, WASHINGTON 98006-6531.

The right to be modified, as evidenced by a portion of Certificate 57497, was perfected under Permit 40706 with a date of priority of FEBRUARY 27, 1976. The right allows the use of LAMBERT SLOUGH, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 15.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 cubic foot per second, if available at the authorized point of diversion: DIVERSION POINT 1 - LOT 8 (SW½ SW½), SECTION 3, T 5 S, R 3 W, W.M.; 650 FEET SOUTH AND 410 FEET EAST FROM THE NE CORNER OF COOPER DLC 53, DIVERSION POINT 2 - LOT 13 (SW½ SE½), SECTION 3, T 5 S, R 3 W, W.M.; 150 FEET NORTH AND 3000 FEET EAST FROM THE NE CORNER OF COOPER DLC 53, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

LOT 8(SW¼ SW¼) 0.8 ACRE LOT 9(SE¼ SW¼) 8.9 ACRES SECTION 3

LOT 3 (NE¼ NW¼) 4.5 ACRES LOT 3 (NW¼ NW¼) 0.8 ACRE SECTION 10

TOWNSHIP 5 SOUTH, RANGE 3 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:

LOT 2 (NE¼ NE¼) 8.5 ACRES LOT 2 (NE¼ NW¼) 6.5 ACRES SECTION 10

TOWNSHIP 5 SOUTH, RANGE 3 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2000.
- 2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 57497 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
