# **Authority**

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right.

OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

# **Findings of Fact**

# Background

- 1. On May 29, 2007, Cynthia A. Edwards filed an application to change the place of use for a portion of the lands under Certificates 50143, 43986 and the point of diversion for a portion of the lands described under Certificates 51335, 50143, 43986, 43985 and 24152. The Department assigned the application number T-10395.
- 2. The portion of the first right to be transferred is as follows:

Certificate: 24152 in the name of David S. Blair (perfected under Permit S-24619)

**Use: SUPPLEMENTAL IRRIGATION of 7.2 ACRES** 

**Priority Date:** DECEMBER 4, 1956 **Rate:** 0.09 CUBIC FOOT PER SECOND

- 15. Notice of the application for transfer was published on June 5, 2007, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 16. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. This diversion may be eligible for screening cost share funds.
- 17. On August 3, 2007, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10395 to the applicant. The draft Preliminary Determination set forth a deadline of September 7, 2007, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination with correction of some identified scrivener's errors in Finding of Fact No. 24 of the draft document, and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 18. On September 12, 2007, the Department issued a Preliminary Determination proposing to approve Transfer T-10395 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on September 18, 2007, and in the Grants Pass Daily Courier newspaper on October 3, 10 and 17, 2007, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

# Transfer Review Criteria [OAR 690-380-4010(2)]

- 19. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610
- 20. Pumps, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Application T-10395.
- 21. The proposed change would not result in enlargement of the rights provided the diversion of water under Certificates 24152 and 51225 and a portion of Certificate 50143 is limited to availability of water at the original diversion points on May Creek. Therefore, when May Creek, the water source for Certificate 24152 and 51225 and a portion of Certificate 50143 goes dry, irrigation will end under those portions of those water rights, even if there is still water in Evans Creek.
- 22. The proposed changes would not result in injury to other water rights.

# Partial Cancellation of a Water Right

- 23. On May 29, 2007, three affidavits were received certifying that portions of three water rights have been abandoned and requesting cancellation of the portions of the rights were received from Cynthia A. Edwards.

# **Conclusions of Law**

The changes in place of use for portions of lands under Certificates 50143, 43986 and changes in the point of diversion under Certificates 51335, 50143, 43986, 43985, and 24152, proposed in application T-10395 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the abandoned portions of the rights should be cancelled.

# Now, therefore, it is ORDERED:

- 1. The changes in place of use for portions of lands under Certificates 50143, 43986 and the point of diversion under Certificates 51335, 50143, 43986, 43985, 24152 proposed in application T-10395 are approved. The portions of the rights that have been abandoned are cancelled.
- 2. Water right certificates 51335, 50143, 43986, 43985, 24152 are cancelled. New certificates will be issued describing the portions of the rights not affected by this transfer and cancellation.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 51335, 50143, 43986, 43985, 24152 and any related decree.
- 4. The quantity of water diverted at the new reach within which a portable pump will divert water, shall not exceed the quantity of water lawfully available at the original point of diversion.

5. Diversion of water under the transferred portions of the rights evidenced by Certificates 24152 and 51335 and 50143 is limited to availability of water at the original diversion point on May Creek, being:

When May Creek goes dry, irrigation will end under the transferred portions of those water rights, even if there is still water in Evans Creek.

- 6. The former place of use of the transferred rights shall no longer receive water under the rights.
- 7. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
- 8. Prior to diverting water, the water user shall install an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain and operate the measuring device as required by the Department
- 9. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2009**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 10. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
