Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On October 3, 2005, Jack E. Stevens filed an application to change the place of use and character of use under Certificates 74028, 74031, and 73996. The Department assigned the application number T-10014.
- 2. On October 26, 2005, Larry M. Toll, CWRE for the applicant, submitted a new amended map which correctly describes the proposed "to" lands.
- 3. The first portion of the first right to be transferred is as follows:

Certificate: 74028, in the name of Rock Creek District Improvement Company

(perfected under Permit S-6807)

Use: Irrigation of 3.0 acres

Priority Date: May 23, 1925

Rate 0.037 cubic foot per second (cfs)

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent.

Sources: Gate Creek and Rock Creek, tributaries of the White River

- 11. Notice of the application for transfer was published on October 11, 2005, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 12. On May 5, 2008, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10014 to the applicant. The cover letter for the draft Preliminary Determination set forth a deadline of June 6, 2008, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

13. On September 2, 2008, the Department issued a preliminary determination proposing to approve Transfer T-10014 and mailed a copy to the applicant. Additionally, notice of the preliminary determination for the transfer application was published on the Department's weekly notice on September 9, 2008, and in the The Dalles Chronicle newspaper on September 19, 26, and October 3, 2008, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 14. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 15. Diversion structures and canals sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-10014.
- 16. The proposed changes would not result in enlargement of the rights.
- 17. The proposed change would not result in injury to other water rights.

Conclusions of Law

The changes in place of use and the change in character of use proposed in Transfer Application T-10014 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in place of use and the change in character of use proposed in Transfer Application T-10014 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 74028, 74031 and 73996 and any related decree.
- 3. Water right certificates 74028, 74031 and 73996 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer.
- 4. The former places of use of the transferred rights shall no longer receive water under the rights.
- 5. When required by the Department, the water user shall install, maintain and operate an inline flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

- 6. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2010.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 7. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
