## ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7238 submitted by

ARNOLD AND EDITH L. CONZELMANN 16835 SW SCHOLLS-SHERWOOD ROAD SHERWOOD, OREGON 97140-8724.

The right to be modified, as evidenced by a portion of Certificate 40713, was perfected under Permit 32692 with a date of priority of JUNE 22, 1968. The right allows the use of AN UNNAMED DRAINAGE WAY AND RESERVOIR CONSTRUCTED UNDER APPLICATION R-43747, PERMIT R-5025, a tributary of CHICKEN CREEK, for IRRIGATION OF 8.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.1 cubic foot per second, if available at the authorized point of diversion: SE½ SE½, SECTION 19, T 2 S, R 1 W, W.M.; DRAIN - 240 FEET NORTH AND 590 FEET WEST, SUMP - 220 FEET NORTH AND 530 FEET WEST, BOTH FROM SE CORNER OF SECTION 19, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5025.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE¼ SE¼ 8.0 ACRES SECTION 19

TOWNSHIP 2 SOUTH, RANGE 1 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:

NE¼ NE¼ 8.0 ACRES SECTION 30

TOWNSHIP 2 SOUTH, RANGE 1 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2000.
- The former place of use shall no longer be irrigated as a part of this water right.

Certificate 40713 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
