ORDER

Now at this time this matter coming on for consideration before the State Engineer of Oregon on the application of Claude Bradfield, B. T. Haley and M. E. Barnes for a change in point of diversion of water from the Tum-a-lum Branch of the Walla Walla River, and it appearing that notice of publication was prepared setting forth that by a decree of the Court entitled "Little Walla Walla River Irrigation Union et al, vs. Finis Ditch Co. et al" a water right was recognized in the name of Wm. H. Wilmot for the irrigation of 2.55 acres in NEZSEANEA, Section 35, T. 6 N. R. 35 E., with a priority date of 1892, and in the name of Geo. Overturf for the irrigation of 3 acres in SeSENEZ, Section 35, T. 6 N. R. 35 E., with a priority date of 1890, and also in the name of Woodson Cummings for the irrigation of 3 acres with a priority date of 1874, said 3 acres being within the following described tract: Commencing at the NE corner of the NE SE, Section 35, T. 6 N. R. 35 E., running thence West 32 rods; thence South 50 rods; thence East 32 rods; thence North 50 rods to the place of beginning. That all of the acreage under the above rights is irrigated thru the Tumalum Ditch from the Tumalum River.

C. Bradfield, W. W. Barnes and B. T. Haley as successors in interest to the above parties propose to change the point of diversion to a point 800 feet North from the SE corner of the SE of said Section 35, same Township and Range, from Crockett Branch of the Little Walla Walla River.

That said notice was published in the Milton Eagle, a newspaper having general circulation in Umatilla County, for a period of three

successive and consecutive weeks beginning with the issue of April 17th and ending with the issue of May 1st, 1930. And it further appearing that within the time as set forth in said notice no objections were filed to the approval of this transfer and that such change in point of diversion will not be an injury to existing rights to the use of the waters of the Tum-a-lum Branch of the Little Walla Walla River,

NOW THEREFORE, IT IS HERELY ORDERED that the change in point of diversion be and the same is hereby approved.
