## ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8121 submitted by

RIVERBEND-RIVERBANK WATER IMPROVEMENT DISTRICT 31180 SW RIVERLANE ROAD WEST LINN, OREGON 97068.

The right to be modified was perfected under Permit G-10678 with a date of priority of OCTOBER 7, 1986. The right allows the use of A WELL, in the WILLAMETTE RIVER BASIN, for DOMESTIC USE FOR 68 FAMILIES INCLUDING THE IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN AND COMMUNITY SERVICE USES INCLUDING SWIMMING POOL AND SANITARY FACILITIES AT TWO BUILDINGS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 105.0 GALLONS PER MINUTE (GPM); BEING 100.0 GPM FOR DOMESTIC USE AND 5.0 GPM FOR COMMUNITY SERVICE USE, if available at the original well; NW¼, AS PROJECTED WITHIN DLC 46, SECTION 22, T 3 S, R 1 E, W.M.; 660 FEET SOUTH AND 600 FEET EAST FROM THE NW CORNER OF SECTION 22, or its equivalent in case of rotation, measured at the well.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add an additional point of appropriation to:

NW¼ NW¼, AS PROJECTED WITHIN DLC 46, SECTION 22, T 3 S, R 1 E, W.M.; 590 FEET SOUTH AND 575 FEET EAST OF THE NW CORNER OF SECTION 22.

Proof to the satisfaction of the Department has been received that the appropriation was perfected under Permit G-10678.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2000.
- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

- 3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
